Otter Tail Power Company (Otter Tail) respectfully submits to the Minnesota Public Utilities Commission these Reply Comments in response to the Comments received from the Department of Commerce, Division of Energy Resources (Department) dated May 16, 2022, in the above referenced docket.

Otter Tail's Response to Department's discussion requests

1. Why the number of days of job transfer or restriction and days away from work metrics are trending higher than the 10-year average.

Due to an injury that resulted in surgery for repair the number of Days Away were elevated from past years. This was a single incident which Otter Tail incurred and was unfortunate. The employee engaged with an Injury Intervention entity to recover by self-care, unfortunately, the injury would need medical attention to repair. The number of days restricted or transferred were also elevated due to a couple of injuries where restrictions were set by a medical provider for these cases which drove the total upward. We believe that all injuries are preventable and continue to train, educate, and promote safe work behaviors and habits in our employees.



2. Why the number of complaints in 2021 increased by 277 percent over 2020.

In May 2021, Otter Tail completed a specific training with our Customer Service Representative (CSR) team, specifically on complaints. The training included discussion of complaint definition and various situations that a CSR could encounter that could constitute a complaint. This training was intended to provide more clarity surrounding complaints and to enhance their ability to identify if the situation presented is a complaint. Otter Tail completed a follow up session with our CSR team in September 2021 when enhancements to simplify the complaint process within our Customer Information System were completed.

Otter Tail feels that the increase in complaints is due to complaint training sessions and enhancements within our customer information system. This increase represents a change in categorization of the calls received more than a change in level of satisfaction with the service provided to customers. Customer satisfactions for Otter Tail's customers remains very high.
