COMPLIANCE – COST SHARING IMPLEMENTATION PLAN AND TARIFF

INTRODUCTION

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission this implementation plan for the cost-sharing proposal the Commission approved in its March 31, 2022 Order in Docket No. E999/16-521. The Commission's Order requires the Company to submit its implementation plan within 60 days of the Order and implement the approved cost sharing proposal by August 31, 2022. With the 90-day implementation timeline prescribed by the Order, we are taking immediate actions internally to ready our systems and establish the accounting protocols and other processes that are necessary for a successful and timely implementation. We intend to implement this plan effective August 31, 2022 in compliance with the Order unless the Commission directs the Company to suspend or modify its implementation plan.

The Cost Sharing Proposal the Commission approved in its Order for small Distributed Energy Resource (DER), behind the meter projects is intended to reduce risk to customers who have considered a small on-site DER solution that triggers a distribution upgrade, while also protecting all Xcel Energy customers from costs associated with benefits to individual customers.¹ The approved proposal originated from Fresh Energy, All Energy Solar, and TruNorth Solar, as filed in Docket No. E999/CI-16-521 on August 25, 2021 (Original Proposal).² Using this Original Proposal as the starting point, the Company began to outline details of a cost-sharing program that we could efficiently administer. We also continued discussions with Fresh Energy and All Energy Solar to further develop our implementation plan as detailed in this filing.³

Our implementation plan addresses cost-sharing for DER projects 40 kW_{AC} or less,⁴ whose interconnection applications have been Deemed Complete on or after August 31, 2022. These interconnection applications would be required to pay a Cost Sharing Fee of \$200. This fee will be collected to establish a Cost Sharing Fund, which will in turn fund individual DER projects up to \$15,000 for required Upgrades and Area EPS Operator's Interconnection Facilities as defined in the Minnesota Distributed Energy Resource Interconnection Process (MN DIP). This Cost Sharing Proposal is compliant with the Commission's requirement at Order Point 10 which states:

The Commission approves the cost-sharing proposal for Xcel Energy customers with less than 40 kW DER created by Fresh Energy, IREC, and TruNorth with a plan by Xcel Energy to implement by the end of August 31, 2022, within 60 days of this Order, capping individual upgrades at \$15,000.

The Commission's Order requires the Company to submit its implementation plan within 60 days of the Order and implement the approved cost sharing proposal by August 31, 2022. In the remainder of this filing, we describe our implementation plan, which includes a 30-day negative check-off process for ongoing management of the Cost Sharing Fee and provide the associated tariff changes in accordance with Minn. Stat. § 216B.16, subd. 1, for implementation beginning August 31, 2022, unless otherwise directed by the Commission.

Stat. § 216B.16, subd. 2 to suspend or alter the proposed tariff any time in advance of its effective date. In the event the Commission determines this implementation plan and related tariff modifications must be considered within the context of a miscellaneous filing under Minn. R. 7829.0100, subp. 11, the Company provides the required information. In that event, Minn. R. 7829.1400 prescribes the procedural timelines, unless otherwise specified by the Commission.

V. DESCRIPTION AND PURPOSE OF FILING

A. Background

Xcel Energy has experienced an unprecedented growth in DER interconnections since the Company's Solar*Rewards Community program was launched in 2015. Today, we have over 830 MWs of interconnected Community Solar Gardens (CSGs) that are concentrated on certain areas and feeders of the Company's distribution system. Regardless of system size, DER projects are affected by grid impacts in these constrained areas. Adding any new projects on these feeders, even smaller on-site projects, will require substantial system modifications such as replacing or adding substation transformers or creating new or substantially modified feeders. As a result, our interconnection queue shows several rooftop applications that will likely require more extensive distribution and network upgrades to interconnect. The Company continues to see these upgrade costs become more common and, on the rise – averaging approximately \$4,000 per project, and in a few cases, reaching ten or more thousand dollars.⁵ This has the effect of being a barrier for small systems, and it tends to slow down the process for those projects and the projects behind them in the queue. Due to the frequency of these upgrade costs, the Company has heard that some solar installers are now no longer accepting DER customers who live in affected areas.

Various cost-sharing proposals were presented to the Commission in the 2021/2022 timeframe. The Company proposed paying for distribution upgrades for Solar*Rewards projects (those 40 kW_{AC} or less) from its operating budgets.⁶ Fresh Energy, All Energy Solar and TruNorth proposed a cost sharing mechanism in which all DER applicants would pay into a fund specifically set up for future Upgrades. The Department of Commerce supported a cost sharing approach but preferred a proposal in which there was a flat fee paid by interconnection customers rather than all customers.⁷ Ultimately, the Commission determined the cost sharing proposal by Fresh Energy, All Energy Solar, and TruNorth, capped initially at \$15,000 per application, should be adopted and in its March 31, 2022 Order, ordered the Company to submit its implementation plan by May 31, 2022 for implementation by August 31, 2022.

In developing its implementation plan, the Company used the Original Proposal to begin a series of discussions with the originating parties regarding how to move forward into implementation. The plan we outline in this filing and associated Tariff are the result of those discussions and reflects significant agreement on implementation. There are two areas, however, where parties were not in full agreement: (1) making the Cost Sharing Fee refundable, which would be inconsistent with the MN DIP application fee and be administratively impracticable, and (2) whether, or how a seed fund could or should be established, which is out of scope in this initial implementation, given the discussion at the hearing where the Commission approved the Cost Sharing Proposal that clarified there is no initial seeding for this cost sharing mechanism. We discuss both issues below.

B. Cost Sharing Implementation Plan

Our implementation plan requires all DER projects of a specified size to pay a Cost Sharing Fee of \$200 effective August 31, 2022. The Company will establish a Cost Sharing Fund for these Fees, which will serve to fund required Upgrades and Area EPS Operator's Interconnection Facilities up to \$15,000 for qualifying individual DER projects. We provide further detail regarding this implementation plan in this section and in the proposed Tariff we provide as Attachment A.

1. Eligibility

Cost Sharing applies to all projects of $40~kW_{AC}$ or less that are Deemed Complete on or after August 31, 2022. In order to be Deemed Complete, on and after the effective date, all eligible projects will be required to pay both the current Engineering Process Fee (as identified in MN DIP Section 1.5) and the new Cost Sharing Fee of \$200. Generally, for an application moving through the Simplified Process, this would result in cumulative fees totaling \$300 rather than the current \$100 fee for a Simplified Process application.

To illustrate, we note that in 2021, there were close to 2,000 total projects that would have fallen into this eligibility category. Approximately 350 of these applications required an Upgrade or a Supplemental Review, so would be candidates for the Cost Sharing Fund; the remaining 1,600 would have paid into the Fund, but not directly benefit from it, because they did not incur eligible costs as defined in Part 3 below.

2. Cost Sharing Fee Basis and Terms

The Cost Sharing Fee is based on the following formula, using 2021 data as outlined in Table 1, and rounded up to, among other things, help jump-start the Cost Sharing Fund and account for inflationary cost pressures:

(Upgrade Costs Assessed + Supplemental Fees)/Number of Applications

Table 1: 2021 Data and Fee Analysis (Projects < 40 kW AC)

	# of Applications	Upgrade Costs Assessed	Average Project Cost
Deemed Complete	1,960	N/A	N/A
Supplemental Review*	272	\$54,400	\$200
Distribution Upgrades*	63	\$249,543	\$3,960

^{*} Note: the number of Supplemental Review and Distribution Upgrade Applications is a subset of the 1,960 total Applications that were Deemed Complete in 2021.

Using this formula and the 2021 data, the result is \$155, as follows: (\$249,543+\$54,400)/1,960 = \$155

For at least the first year, we believe rounding-up the Cost Sharing Fee to \$200 is appropriate to help seed the Cost Sharing Fund for potential Upgrades, account for inflationary costs and price fluctuation in our supply chain, and the prospect that there may be some applications that previously withdrew due to high interconnection costs that may re-apply to take advantage of this new Cost Sharing mechanism. We further note our concern that, given the high volume of applications already Deemed Complete in the first half of 2022 and the depletion of 2022 Solar*Rewards incentives by the end of May 2022, there will not be sufficient volumes of applications to build a reserve of funds upon which to draw for projects requiring significant Upgrades during at least the first six to nine months of the Cost Sharing Fund. For these reasons, we believe setting the initial Cost Sharing Fee at \$200 is reasonable. We propose to review the Cost Sharing Fund and Cost Sharing Fee on a periodic or annual basis and propose changes to the accordingly, as discussed in Part 5 below.

Once the Cost Sharing Fees begin to be collected and the Fund is established, eligible applicants will begin to be credited with Fund monies on a first-come, first-served basis. Consistent with MN DIP application fees, the Cost Sharing Fee is non-refundable. The Company is unable to refund Cost Sharing Fees that go into the Cost Sharing Fund, as those monies may already be granted to a different project. The Cost Sharing Fund will work similar to a banking account, in that there will be

deposits and withdrawals – and the balance cannot go below zero. Administering a refundable fee introduces an unacceptable level of administrative complexity and is impracticable with the current design of the cost sharing mechanism.

3. Eligible Costs

The Cost Sharing Fund will fund the following types of interconnection costs for eligible projects:

- Fees for Supplemental Review;
- Upgrade Costs; and
- Area EPS Operator's Interconnection Facilities Costs.

For eligible applications, the Cost Sharing Fund will credit the applicant's eligible costs up to \$15,000, subject to Cost Sharing Fund availability.

The maximum \$15,000 cost per application credited from the Cost Sharing Fund will also include the Supplemental Review Fee. We have included the Supplemental Review Fee as an eligible cost to help streamline the overall interconnection process – which we anticipate will help to expedite application review. This provision was included in the Original Proposal, and we believe it will increase the benefit of the cost-sharing for our customers.

Upgrades paid from the Cost Sharing Fund include any work done as part of the Upgrade, including such things as tree trimming, traffic control, restoration, winter construction, etc. Area EPS Operator's Interconnection Facilities Costs include sole use facilities, such as line extensions, controls, relays, switches, breakers, and transformers. The Cost Sharing Fund will not credit any costs related to metering; these remain the Applicant's responsibility.

Where a project's Upgrade cost exceeds the Cost Sharing Fund's \$15,000 cost cap per project or availability of funds, the Company will provide an explanation of what is covered up to \$15,000 or up to Fund availability, and any additional amount due from the Customer as part of the Minnesota Distributed Energy Resource Interconnection Agreement (MN DIA).

4. Cost Sharing Fund – Eligible Pool of Funds

Until the first Cost Sharing Fee is collected, there is no Cost Sharing Fund – the Fund balance begins at zero.

In administering the Fund, the Company must follow General Accounting Rules and receive payment for Upgrade costs/fees associated with the project similar to how MN DIP currently requires payment. We would be unable to pay for Upgrade costs through the Cost Sharing Fund if no funds are available. For example, if 10 applications are submitted, resulting in \$2,000 contributed to the Cost Sharing Fund, and the first applicant has an Upgrade cost of \$15,000, we would be only able to cover \$2,000 of the Upgrade cost due to fund availability. Similarly, if the Fund contains \$20,000 (funded by 100 applicants) and the first applicant has an Upgrade cost of \$15,000, only \$5,000 would remain for the other 99. The fund at no point can become negative. As noted above, the Company will utilize these funds to pay our suppliers under contractual obligations. If monies are not available from the Fund to make those payments, the interconnection customer would need to timely pay for the costs of interconnection for its application to continue to progress.

During conversations with All Energy and Fresh Energy, we have explored how a future iteration of the cost sharing mechanism might establish seed funding, so that the first and other "early" eligible projects would more assuredly benefit from the Cost Sharing Fund. We are continuing those conversations to explore funding options outside of Xcel Energy, and believe this is an overall topic the Commission may want to explore as a possible future expansion of the cost sharing mechanism.

5. Reporting and Proposed Process to Modify Cost Sharing Fee Over Time

Order Point No. 12 of the March 31, 2022 Order requires the Company to "provide a detailed report of the costs incurred and technical rationale for each upgrade should Xcel Energy seek cost recovery for Distribution Upgrades." After further discussion with Fresh Energy and other stakeholders, it was a common understanding that this Ordering Point was in reference to the Company's proposal to pay for upgrade costs for Solar*Rewards projects. Given that the Commission did not accept that proposal, but rather a cost sharing approach, we do not believe this Ordering Point is applicable since the Company will not seek cost recovery for the Cost Sharing Fund because it is 100 percent funded by eligible applicants.

That said, we believe there is benefit in providing additional detail to serve the record. The Company provides the Commission ongoing reporting on the MN DIP process on a quarterly cadence. We propose to report on the Cost Sharing Fund as part of this reporting beginning in 2023, as well as including the following information:⁸

- Total amount of funds available at start of reporting period (at one point in time).
- Total dollar amount of fees received from the number of applications during reporting period (between two points in time).
- Total dollar amount of funds allocated to the number of applications during reporting period.
 - Listing of each project (anonymized) showing dollar amount credited toward overall interconnection costs.
- Total number of projects ineligible for the Fund and reason why.
- Total amount of funds available at end of reporting period (point in time).

The Company anticipates reviewing the Cost Sharing Fee structure and amount on a periodic or annual basis by analyzing associated collected fees and covered expenses as detailed in our Reporting Section below. If adjustments are necessary, the Company will request a tariff modification to update the Fee in Docket No. E002/M-18-714, which we propose to do under a 30-day negative check off process.

Specifically, we ask for the Commission Order approving this implementation plan to permit the Company to proceed with changing the tariffed Cost Sharing Fee 32 days after the Company submits to the Commission a proposed change if all of the following conditions are met:

- The filing includes a red-lined version of the Tariff showing the changes to the Cost Sharing Fee and an explanation of the proposed change; and
- · No objection or intent to object is filed within 30 days of the filing.

C. Proposed Tariff Modifications

This filing proposes tariff provisions to implement the Cost Sharing Proposal as follows:

Minnesota Electric Rate Book Section 10, Sheet No. 204.01

We provide the redlined and clean tariff sheets as Attachment A to this filing.

VI. EFFECT OF CHANGE UPON XCEL ENERGY REVENUE

No significant revenue effect net of incremental costs is expected. The tariff revisions associated with this implementation plan allow Xcel Energy to assess certain new or different fees and are expected to be offset by associated costs.

CONCLUSION

Xcel Energy submits this implementation plan and associated Tariff to take effect August 31, 2022 in compliance with the Commission's March 31, 2022 Order in Docket No. E999/CI-16-521.

Section 6. Cost Sharing Provisions, Terms, and Conditions

6.1 Applicability

These Cost Sharing provisions, terms and conditions apply to every MN DIP application with 40 kW AC or less that has been Deemed Complete under MN DIP 1.5.2 on or after August 31, 2022.

6.2 Fee applicable to applications

A mandatory cost sharing fee of **\$200** is applicable to every application subject to these Cost Sharing provisions. Payment of this fee is a prerequisite to the application being Deemed Complete under MN DIP 1.5.2. This fee is non-refundable and in addition to the applicable MN DIP processing fee associated with each application.

6.3 Costs Shared

Subject to having funds available that have been collected by the cost sharing fee, and subject to a cap of \$15,000 per project, the following costs are to be paid from the funds collected:

- 6.3.1 Supplemental Review fees
- 6.3.2 Network Upgrade and Distribution Upgrade costs
- 6.3.3 Area EPS Operator's Interconnection Facilities costs (but, not including metering costs)

The following costs are not to be paid from the funds collected under MN DIP 6.2: System Impact Study costs, Facilities Study costs, Phase II Study costs, and costs associated with MISO review. Notwithstanding this, where the project is of a size/type and situation where the Area EPS Operator conducts a Facilities Study but ordinarily does not charge the Interconnection Customer for the Facilities Study, then this process of not charging for the Facilities Study shall apply to similarly situated projects that are subject to this section.

6.4 First Come, First Served

Where funds are collected under MN DIP 6.2, these funds are available on a first come, first served basis. If on a given date there are insufficient funds available to pay for costs detailed in MN DIP 6.3, then the Interconnection Customer is responsible for these costs even if it has paid the cost sharing fee.

The costs associated with MN DIP 6.3.1 through 6.3.3 shall require no contributions from the Area EPS Operator nor its ratepayers and are to be funded by the funds collected from the Interconnection Customers. To the extent that there are insufficient collected funds available to pay these costs, then the Interconnection Customer is responsible for paying these costs.

6.5 Authorization to Proceed with Supplemental Review

Where the collected funds are sufficient to cover the costs of Supplemental Review, then no further payment or confirmation from the Interconnection Customer is required for the Interconnection Application to proceed to Supplemental Review. This is so notwithstanding MN DIP 3.4.1 et seq. In this situation, the 30 Business Day timeline for completing the Supplemental Review under MN DIP 3.4.4 shall commence when the Initial Review results are shared with the Interconnection Customer showing a need for Supplemental Review.

Section 6. Cost Sharing Provisions, Terms, and Conditions

6.1 Applicability

These Cost Sharing provisions, terms and conditions apply to every MN DIP application with 40 kW AC or less that has been Deemed Complete under MN DIP 1.5.2 on or after August 31, 2022.

6.2 Fee applicable to applications

A mandatory cost sharing fee of **\$200** is applicable to every application subject to these Cost Sharing provisions. Payment of this fee is a prerequisite to the application being Deemed Complete under MN DIP 1.5.2. This fee is non-refundable and in addition to the applicable MN DIP processing fee associated with each application.

6.3 Costs Shared

Subject to having funds available that have been collected by the cost sharing fee, and subject to a cap of \$15,000 per project, the following costs are to be paid from the funds collected:

- 6.3.1 Supplemental Review fees
- 6.3.2 Network Upgrade and Distribution Upgrade costs
- 6.3.3 Area EPS Operator's Interconnection Facilities costs (but, not including metering costs)

The following costs are not to be paid from the funds collected under MN DIP 6.2: System Impact Study costs, Facilities Study costs, Phase II Study costs, and costs associated with MISO review. Notwithstanding this, where the project is of a size/type and situation where the Area EPS Operator conducts a Facilities Study but ordinarily does not charge the Interconnection Customer for the Facilities Study, then this process of not charging for the Facilities Study shall apply to similarly situated projects that are subject to this section.

6.4 First Come, First Served

Where funds are collected under MN DIP 6.2, these funds are available on a first come, first served basis. If on a given date there are insufficient funds available to pay for costs detailed in MN DIP 6.3, then the Interconnection Customer is responsible for these costs even if it has paid the cost sharing fee.

The costs associated with MN DIP 6.3.1 through 6.3.3 shall require no contributions from the Area EPS Operator nor its ratepayers and are to be funded by the funds collected from the Interconnection Customers. To the extent that there are insufficient collected funds available to pay these costs, then the Interconnection Customer is responsible for paying these costs.

6.5 Authorization to Proceed with Supplemental Review

Where the collected funds are sufficient to cover the costs of Supplemental Review, then no further payment or confirmation from the Interconnection Customer is required for the Interconnection Application to proceed to Supplemental Review. This is so notwithstanding MN DIP 3.4.1 et seq. In this situation, the 30 Business Day timeline for completing the Supplemental Review under MN DIP 3.4.4 shall commence when the Initial Review results are shared with the Interconnection Customer showing a need for Supplemental Review.
