## **APPENDIX N: CROSS REFERENCE INDEX**

Appendix N provides a cross reference of filing requirements contained in Minnesota Statutes and Rules applicable to the filing and content of resource plans and the plan sections and/or appendices that contain information to fulfill a requirement. In addition, this section identifies those items the Minnesota Public Utilities Commission included in its Orders that have required additional information to be included in its future resource plan filings.
