Thank you for continuing consultation on the above referenced project. Information received on April 18, 2022, has been reviewed pursuant to the responsibilities given the State Historic Preservation Office by the Minnesota Historic Sites Act (Minn. Stat. 138.665-666).

According to your correspondence, ConEdison Development, operating as Rose Creek, LLC is proposing to repower an existing wind farm in Mower County. The proposed project includes the decommissioning of 11 existing wind turbines, constructing up to 7 new, larger wind turbines, and installing new collector lines, staging areas, and construction access roads.

We have reviewed the following documentation that was included with your April 18th submission:

- Merjent cover letter and associated project maps (dated April 18, 2022)
- Report: Phase I Archaeological Survey, Rose Creek Repower Project, Mower County, Minnesota (Merjent, April 2022)
- Report: Architecture-History Effects Analysis, Rose Creek Wind Project, Mower County (Streamline Associates, January 25, 2022)

Our comments are provided below.

Archaeological Resources

According to the April 2022 Phase I archaeological survey report, there were no archaeological sites identified within the project area during the field investigations. We understand that there is additional Phase I survey work that will be completed this summer. We look forward to reviewing the result of the additional survey work when it becomes available.

History/Architecture Projects

As stated in the Architecture-History Effects Analysis Report, there is one historic property located within ½ mile of the project area, the Adams State Bank, which is listed in the National Register of Historic Places. We agree with your determination that the project, as currently proposed, will have **no adverse effect** on the Adams State Bank.

Tribal Consultation

According to your correspondence, the Minnesota Department of Commerce Tribal Liaison initiated consultation with the Tribal Historic Preservation Officers for the eleven (11) federally recognized tribes in Minnesota back in 2021. The Lower Sioux Community, the Upper Sioux Community, and the Shakopee Mdewakanton Sioux Community responded that they have an interest in the project. We understand that Merjent and Rose Creek will continue to consult with these three tribes as the design for the project proceeds. Please keep our office informed if any tribes express concern or disagreement with efforts to identify historic properties and/or the assessment of effects for this project.
