Background: In a series of proceedings, the Commission established a biennial Renewable Energy Standard (RES) compliance process to fulfill its obligations under Minn. Stat. §216B.1691, subd. 7 to "regularly" investigate whether an electric utility is in compliance while coordinating with the Department of Commerce's biennial report to the legislature on the same issues. As with prior biennial RES compliance dockets, the Commission intends to make formal findings on utilities' compliance with the RES.
