Dear Mr. Seuffert:

The Canadian Association of Petroleum Producers (CAPP) represents companies, large and small, that explore for, develop and produce natural gas and oil throughout Canada. CAPP's member companies produce about 80 per cent of Canada's natural gas and oil.

In addition, many CAPP member companies are diverse businesses that also own U.S. assets, including refiners, and three of our members were part of the Shippers for Secure, Reliable and Economical Petroleum Transportation (Shippers Group) that intervened in the certificate of need docket for Line 3 Replacement Project (now referred to as Line 93).

CAPP has continued to follow proceedings before the Minnesota Public Utilities Commission (Commission) concerning Line 93, including the above-referenced docket regarding establishing and funding a decommissioning trust fund for the Line 93 pipeline. CAPP understands that certain comments have been submitted in this docket concerning shippers as it relates to the Decommissioning Trust Fund, particularly the timing and amount of funding. CAPP submits these comments to clarify the Commission's record. Specifically, Enbridge and shippers have contractually agreed to an economic life of 30 years for Line 93. The agreement between Enbridge and shippers provides that the decommissioning costs ordered by the Commission will be included in Enbridge's rates for Line 93.
