**Issue:** Should the Commission grant the Minnesota Large Industrial Group's (MLIG) petition for expedited relief to amend its March 13, 2023 Order?

**Topic(s) Open for Comment:**

- Should the Commission adopt the proposed amendment to its March 13, 2023 Order to bring the Open Data Access Standards into compliance with H.F. 2310 as recommended by MLIG?

**Background:** On June 2<sup>nd</sup> 2023, MLIG submitted a petition to amend the Commission's March 13, 2023 Order<sup>1</sup> to bring it into compliance with H.F. 2310 which was signed into law on May 24, 2023.<sup>2</sup> Relevant here is Minn. Stat. § 216C.331 which states at Subd. 8(d):

"Notwithstanding any other provision of law, a qualifying utility shall not aggregate or anonymize customer energy use data of any customer exempted by the commissioner under section 216B.241 from contributing to investments and expenditures made by a qualifying utility under an energy and conservation optimization plan, unless the customer provides written consent to the qualifying utility."

MLIG proposed adding language to the Commission's Open Data Access Standards (ODAS or "the Standards"), which were included within the Commission's March 13, 2023 Order, that would account for the exemption described above. The Standards set statewide rules for third-party access to aggregated or anonymized customer energy use data (CEUD).

The Commission has expedited the comment period on this petition pursuant to Minn. Rule 7829.1275.
