Issue: What clarifications, if any, must be made regarding electric utilities subject to reporting under Minn. Stat § 216B.1691?

Topic(s) Open for Comment:

1. Whether and how municipal power agencies are subject to reporting under Section 216B.1691 as an “Electric Utility.”
 - a. Should the Commission require each municipal power agency to identify which of its members’ electric sales are reported by another entity, which entity is reporting for each member, and the percentage of the member’s sales reported by that entity.
 - b. Should the Commission require each municipal power agency to identify any member’s retail power sales that are not reported for purposes of Minn. Stat. § 216B.1691?
 - c. Should the Commission require each municipal power agency to make a compliance filing identifying a point of contact (name, address, contact information) for purposes of enforcing compliance with Minn. Stat. § 216B.1691?
 - d. Are there other matters associated with municipal power agencies that should be reported to the Commission in connection with Minn. Stat. § 216B.1691?

2. Should the Commission require that any entity that intends to report on behalf of one or more electric utilities newly subject to Section 216B.1691, displayed in Table 1 below, identify:
 - a. The electric utilities they intend to report on behalf of; and
 - b. The portion of each electric utilities' total retail electric sales covered by the report?

(Ex. If a public utility supplies a distribution utility with 100% of the energy they consume in a year, the public utility would name the distribution utility they are reporting for, and state that 100% of the distribution utility's energy sales will be covered by its report.)

3. Please identify any distribution cooperatives that serve fewer than 50 Minnesota customers (such as those located near the state's border), that have not been included in the list of Electric Utilities displayed in Table 1 below who are included in the definition of "electric utility" in Section 216B.1691. Does the Commission have any authority to modify these utilities' obligation to comply with Section 216B.1691? If so, how should the obligations be modified?
4. Are there any other issues helpful to the Commission's implementation of Minn. Stat. § 216B.1691?

Supplemental Topics – As discussed below, staff request that parties address the following topics in the reply and supplemental comment periods

5. Should municipal power agencies that do not supply energy, like Northeastern Municipal Power Agency, be considered an "electric utility" under Section 216B.1691 and thus be included in the Commission's list of electric utilities?
 - a. Do such municipal power agencies meet the statutory definition of a municipal power agency provided in Minn. Stat. § 453.52, or the legislative intent described in Minn. Stat. § 453.51?
6. Should the Commission consider alternate reporting requirements for MPAs that do not supply energy in order to monitor whether the MPA's members' energy sales are being accounted for in other electric utilities' RES and SES compliance reports?
 - a. If so, what reporting requirements should the Commission consider?

Background

On October 19, 2023, the Commission met to consider several amendments made to Minn. Stat. §216B.1691 by House File 7 (H.F. 7), which became effective on February 8, 2023. Specifically, the Commission heard comments on whether clarifications were necessary following an amendment to the definition of "electric utility" that expanded the types of entities that must comply with the statute, and how to address changes made to the reporting requirements.

The Commission’s December 6, 2023, Order¹ clarified, among other things, that the following utilities are subject to the renewable energy standard under the revised definition of “electric utility” established in Minn. Stat. § 216B.1691, subd. 1(d):

On December 20, 2023, the Commission filed a notice of comment period with the intent of following up on several unanswered questions from this proceeding. By January 19, 2024, the Commission received initial comments in response to its notice.

As described in its December 20, 2023, Notice, the Commission intends to clarify the reporting obligations for a municipal power agency (“MPA”) as an “electric utility” on behalf of their members.² The Commission recognized that some MPAs do not sell power to their members and

therefore would have no sales to report under the statute. This creates an avenue for municipal utilities to avoid RES and CFS reporting by joining an MPA that does not sell power.

To ensure there is sufficient record development on this topic, Commission Staff has filed this notice with two new supplemental topics open for comment for parties to respond to in their reply comments. To ensure parties have enough time for their analysis, Staff has extended the reply comment period and added a supplemental comment period to allow parties to respond to any comments made on these supplemental topics.
