

RE: Request for Comments on Lake Wilson Solar Energy Project in Murray Co, MN

Dear Jaylen Strong:

On behalf of Lake Wilson Solar Energy LLC (Lake Wilson Solar), Invenergy LLC is gathering information and requesting agency comments for the proposed Lake Wilson Solar Project (Project) in Murray County, Minnesota (**Figure 1**). The purpose of this letter is to inform you of the proposed Project, request comments or questions from you regarding the Project, seek your input concerning permits or approvals that may be required, and identify other interests you may have within or near the Project area.

Lake Wilson Solar contracted Westwood Professional Services, Inc. (Westwood) of Minnetonka, Minnesota to conduct a Phase I Archeological Survey in November 2021 for the proposed Project. The Project will be comprised of 150-megawatt (MW) solar energy generation and related facilities. At this time, the Project is being conducted at a state-level review due to anticipated requirements of the Minnesota Public Utilities Commission (PUC) as part of the Site Permit (SP) Application process as required under the Power Plant Siting Act (Minnesota Statutes Chapter 216E). The Project area consists of approximately 2,677 acres. The proposed footprint of the Project is approximately 1,581 acres. Land use within the Project area is currently row-crop agriculture.

On September 15 and 16, 2021, Westwood Cultural Resources Manager Ryan Grohnke examined files maintained by the Office of the State Archaeologist (OSA) and the Minnesota State Historic Preservation Office (SHPO). Review of information from these offices included an examination of site maps, archaeological site forms, burial files, historic structure inventories, and survey reports for the Project area and surrounding one-mile buffer. No previously recorded resources were found to be present in the area examined.

Fieldwork was carried out by Westwood Principal Investigator Rigden Glaab and Archaeological Technicians Brian Joby Hunt, Ryan Steeves, Lindsay Schwartzkopf, and Daniel Schneider between November 16 and November 19, 2021. No cultural resources were identified within the Project Area of Potential Effect (APE) by Westwood archaeologists during the Phase I Survey. The Project APE consisted of the 2021 proposed Project footprint of 1,574 acres. Additional surveys for new portions of the Project Area are planned for the fall of 2022.

Although an archaeological survey was completed, the possibility of unidentified resources remains. If unrecorded archaeological sites are discovered during construction, all ground-disturbing activities in the area will stop and archaeologists at Westwood will be contacted. Further, if human remains are encountered during construction activities, all ground disturbing activity will cease and local law enforcement will be notified.

We welcome any comments may have at this time and throughout the PUC SP and Certificate of Need application processes. Please provide comments within 30 days of receipt of this letter. Any written comments provided in response to this letter will be incorporated into the PUC's review of the SP Application.


