Thank you for continuing consultation on the above referenced project. Information received on July 29, 2022, has been reviewed pursuant to the responsibilities given the State Historic Preservation Office by the Minnesota Historic Sites Act (Minn. Stat. 138.666).

According to your submission, Lake Wilson LLC is proposing to develop a 150 MW Solar Energy Facility (Project) on approximately 1,581 acres in Murray County. The proposed project will include the installation of solar modules, inverters, and racking, onsite electrical collection lines, a substation, a main power transformer, a battery storage system, an overhead transmission line, a utility switchyard, fencing, an O&M building, and associated access roads.

We previously commented on this project in a letter December 15, 2021, recommending that a background literature review for architectural and archaeological resources be completed for this Project. We also recommended that a Phase Ia archaeological assessment be completed for this project. If, as a result of this assessment, a Phase I archaeological survey is recommended, this survey should be conducted. The survey must meet the requirements of the Secretary of the Interior's Standards for Identification and Evaluation and should include an evaluation of National Register eligibility for any properties that are identified. For a list of consultants who have expressed an interest in undertaking this type of research and archaeological surveys, please visit the website https://www.mnhs.org/shpo/preservation-directory, and select "Archaeologists, Contract" in the "Specialties" box.

The Project should consider not only direct impacts to cultural resources, but potential indirect impacts as well. The analysis completed for indirect impacts should take into account any introduction of visual, atmospheric or audible elements that may have an effect on cultural resources (including architectural resources that are listed in the National or State Register of Historic Places and archaeological sites). Indirect effects can also include changes to a historic property's use.

The resulting cultural resources report should include maps with clearly defined project areas including the location of the solar modules and associated equipment, any laydown yards, transmission lines, collector lines, access roads, and any other above-ground equipment structures (i.e. substations, operation and maintenance buildings, etc) in relation to any identified cultural resources (architectural properties and archaeological sites). The report should discuss ways in which the project will avoid impacting, both directly and indirectly, any cultural resources that are identified.

Thank you for continuing consultation on the above referenced project. It has been reviewed pursuant to the responsibilities given the State Historic Preservation Office by the Minnesota Historic Sites Act (Minn. Stat. 138.665-666).

Lake Wilson LLC is proposing to develop a 150 MW Solar Energy Facility (Project) on approximately 1,526 acres in Murray County. The proposed project will include the installation of solar modules, inverters, and racking, onsite electrical collection lines, a substation, a main power transformer, a battery storage system, an overhead transmission line, a utility switchyard, fencing, an O&M building, and associated access roads.

We have reviewed the cultural resources survey report: A Report for Phase I Archaeological Survey, Lake Wilson Solar Project, Murray County, Minnesota (November 22, 2022) as prepared by Westwood. We understand that the survey was completed at a pace that exceeds some national guidance and recommended best practices from other states. However, based on our review of the documentation provided, we conclude that there are **no properties** listed in the National or State Registers of Historic Places and no known or suspected archaeological properties in the area that will be affected by this project.
