Otter Tail Power Company (Otter Tail or the Company) submits to the Minnesota Public Utilities Commission this supplemental filing to provide additional evidence and information to its initial petition for the Transmission Cost Recovery Rider Docket No. E017/M-23-152. Otter Tail provides additional information showing the Lake Ardoch – Oslo 115 kV project is an approved facility within MTEP.

At the MISO 3rd West Subregional Planning meeting held on September 17, 2023, MISO presented the Lake Ardoch – Oslo 115 kV facility to stakeholders.¹ In addition, MISO documented the ownership change that was occurring between Otter Tail and Minnkota Power Cooperative (Minnkota Power) on this facility, along with documenting the facility being moved from Minnkota project #17424 to the Otter Tail project #4232, which is an approved project and was approved in MTEP19. The provided 20230907 WSPM NWMN MTEP23 screenshot also shows the information on the Lake Ardoch – Oslo 115 kV facility provided at the West Subregional Planning meeting.

After MISO presented on the Lake Ardoch – Oslo 115 kV facility, the facility was approved and added to Otter Tail project #4232, which is an Appendix A approved MISO project. MISO maintains the most current and up-to-date information on MTEP projects and facilities in its MTEP Planning Portal. Otter Tail has provided a screenshot from the MISO MTEP Planning Portal of MTEP project #4232, which shows it is an approved Appendix A project and contains facility #24554, which is the Lake Ardoch – Oslo 115 kV facility. The MTEP Planning Portal is accessible to the public, and non-confidential information is available publicly. The instructions to gain access to the MISO Planning Portal are available on the MISO website² if additional information is desired on any MTEP project.

The project was approved on December 7, 2023. The reasoning for the screenshot in place of Otter Tail's usual methodology for proof of approval was due to the apparently inadvertent exclusion of the project's write up from the MTEP23 report. Rather than reissue or update the MTEP23 report, MISO

With the MISO approval of this facility, Otter Tail satisfies the missing eligibility criteria as stated in the Response Comments of the Minnesota Department of Commerce, Division of Energy Resources Dock No. E017/M-23-152 dated November 13, 2023, referencing the Department Comments, Comments, § 216B.16, subd. 7b(a)(2) explaining eligibility criteria.
