Dear Mr. Seuffert:

Onward Energy Holdings, LLC ("Onward Energy") respectfully submits this letter in response to the Public Utilities Commission Staff Briefing Papers in advance of the March 21, 2024 meeting. This letter is intended to clarify information presented in the Briefing Papers and provide Onward Energy's positions on Staff's decision options presented in the Briefing Papers.

A. Clarification of Table 1 Summary of Bids

Onward Energy offers several clarifications regarding information presented in the Summary of Bids, Table 1 of Staff's briefing papers:.

- First, Onward Energy clarifies that Mankato Energy Center is the facility to be included in the "Bid" column. Onward Energy further clarifies that the size of the facility is 375 MW to be included in the "Size" column. Onward Energy inadvertently designated the name and size of the facility as Trade Secret.
- Second, Onward Energy notes that its Mankato Energy Center facility is a "Natural Gas CC," not a "Natural Gas CT as represented in the "Project Type" column. Onward Energy further clarifies that its bid can be reflected more precisely in the "Project Type" column as the following three distinct alternatives: (i) "Natural Gas CC;" (ii) "Natural Gas CC with Diesel Black Start;" and (iii) "Natural Gas CC with BESS Black Start."

B. Comments on Decision Options

- Issue #1: Completeness – Onward Energy supports decision option 1.e., finding Onward Energy’s bid complete based on the initial filing and the additional information submitted in response to the Department’s initial evaluation. Onward Energy does not take a position on the completeness of any of the other bids.
- Issue #2: Referral to OAH – Onward Energy supports decision option 3 to refer the matter to OAH for a contested case proceeding. However, Onward Energy is open to another procedural approach the Commission considers more appropriate under the circumstances.
- Other Issues: Clean Grid Alliance Recommendations – Onward Energy does not take a position on decision options 5, 6 and 7.
