Rondo Energy, Inc. ("Rondo") respectfully submits this letter in response to the Minnesota Public Utilities Commission Staff Briefing Papers filed on March 13, 2024 ("Staff Briefing Papers"), ahead of the Commission agenda meeting on March 21, 2024.

A. Omission of Rondo's Proposal in Staff Briefing Papers

In the Staff Briefing Papers, under Relevant Documents, Staff only included Rondo's Reply Comments dated February 27, 2024. We note that Rondo's initial filings with the proposal and attachments have been omitted from the Relevant Documents list.

The Staff Briefing Papers did, however, include Rondo in *Table 1. Summary of Bids*, ¹ provide a summary of Rondo's proposal under Project Bids, item VII, ² include Rondo in *Table 2. Department's Analysis of Completeness* noting Rondo did submit supplemental materials, ³ and noted that Rondo submitted reply comments with additional information in response to the Department's initial evaluation of completeness. ⁴




Figure 1. Screen capture of Legistar webpage for the March 21, 2024 PUC Agenda Meeting.⁵
