Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits this Property Tax True-Up Report for 2022 pursuant to the Minnesota Public Utilities Commission's July 17, 2023 FINDINGS OF FACT, CONCLUSIONS, AND ORDER (ORDER) in Docket No. E002/GR-21-630. We provide the results of the property tax true-up for 2022 below.

A. Property Tax True-Up for 2022

The Order in the above-noted docket set the level of property tax included in rates and approved the property tax true-up mechanism for the duration of the multiyear rate plan¹. For purposes of this report, we true up 2022 actual property tax expense to the established baseline amount in base rates as shown in Attachment B, page 2 of 3.

Attachment A to this report provides itemized property taxes by Minnesota counties and the total 2022 NSPM (includes Minnesota, North Dakota, and South Dakota) property tax amount. As presented in Attachment B, Page 3, when allocated to the State of Minnesota, the 2022 Minnesota electric jurisdictional actual property taxes are \$154.4 million, less \$20.4 million collected through riders, which leaves an amount of \$134.0 million for comparison to the baseline amount in base rates. Page 2 provides the rate case comparison for the 2022 Test Year based on the Order. The comparison of these actual and baseline property taxes excluding amounts recovered in riders results in a refund of \$11.3 million, as presented in Attachment B, Page 1. Consistent with the Company's proposal in the rate case this refund will be combined with other compliance filing refunds related to the Minnesota electric jurisdiction in 2022.

B. Combined Customer Refund Plan

Consistent with past practice, we propose combining the property tax refund to customers with refunds for the Incentive Compensation Plan, Capital True-up, and Net Operating Loss (NOL). In this section, we discuss the components of the proposed combined refund and summarize our refund plan.

1. Property Tax Refund for 2022

We will refund approximately \$11.3 million to customers through a one-time bill credit plus interest with accrual beginning on November 3, 2023, through the month immediately preceding the billing cycle in which the Company issues the refund. The Company proposes to apply interest at an annual rate of 3.73 percent, which is the Company's current Commission-ordered cost of short-term debt.²

We will allocate property tax refund dollars to customer class based on how 2022 property taxes were allocated using Commission-approved class cost allocation methods in the Company's most recent rate case.³ The planned refund method accurately reflects how property tax expense has been collected from customers.

Attachment C to this annual report provides the allocation to customer class and interest calculations for the property tax component of the combined refund. The total calculated refund, including estimated interest of \$229,804, is \$11,576,468. The estimated average refund amount for a typical residential electric customer will be approximately \$4.29, including interest.

2. *Incentive Compensation Plan Refund for 2022*

As reported in our annual report regarding the Company's 2022 Incentive Compensation Plan being filed concurrently with this report,⁴ when comparing the amounts paid capped at 15 percent of an individual's base salary to the amounts approved in electric base rates, we paid approximately \$1.4 million less in 2022 electric utility incentive compensation costs in Minnesota than we recovered through rates.

We thus plan to return approximately \$1.4 million to electric customers through a one-time bill credit. We will allocate Incentive Compensation Plan refund dollars to customer class based on 2022 revenues approved by the Commission in the Company's last rate case.⁵ Consistent with our proposal for the property tax refund, we propose to apply interest to the refund at the cost of short-term debt ordered in the Company's most recent rate case with accrual beginning on November 3, 2023 through the month immediately preceding the billing cycle in which the Company issues the refund to customers.

Attachment D to this annual report provides the allocations to customer class and interest calculations for the Incentive Compensation Plan component of the combined refund. The total calculated refund, including estimated interest of \$28,907, is \$1,456,214. The estimated average refund amount for a typical residential electric customer will be approximately \$0.48, including interest.

3. *Capital True-up Refund for 2022*

As reported in our annual report regarding the Company's 2022 Capital True-up being filed concurrently with this report,⁶ our actual 2022 capital-related revenue requirements were approximately \$13.5 million lower than the approved capital-related revenue requirements.

We thus plan to return approximately \$13.5 million to electric customers through a one-time bill credit. We will allocate the refund dollars to customer class based on how 2022 rate base was allocated using Commission-approved class cost allocation methods in the Company's most recent rate case.⁷ Consistent with our proposal for

the property tax refund, we propose to apply interest to the refund at the cost of short-term debt ordered in the Company's most recent rate case with accrual beginning on November 3, 2023 through the month immediately preceding the billing cycle in which the Company issues the refund to customers.

Attachment E to this annual report provides the allocations to customer class and interest calculations for the Capital True-up component of the combined refund. The total calculated refund, including estimated interest of \$273,786, is \$13,792,063. The estimated average refund amount for a typical residential electric customer will be approximately \$4.89, including interest.

4. *Net Operating Loss for 2022*

As reported in our annual report regarding the Company's 2022 NOL being filed concurrently with this report,⁸ our actual 2022 deferred tax asset revenue requirement increase was approximately \$1.6 million lower than the amount authorized in final rates.

We plan to return approximately \$1.6 million to electric customers through a one-time bill credit. We will allocate the refund dollars to customer class based on how 2022 rate base was allocated using Commission-approved class cost allocation methods in the Company's most recent rate case.⁹ Consistent with our proposal for the property tax refund, we propose to apply interest to the refund at the cost of short-term debt ordered in the Company's last rate case with accrual beginning on November 3, 2023 through the month immediately preceding the billing cycle in which the Company issues the refund to customers.

Attachment F to this annual report provides the allocations to customer class and interest calculations for the NOL component of the combined refund. The total calculated refund, including estimated interest of \$32,950, is \$1,659,859. The estimated average refund amount for a typical residential electric customer will be approximately \$0.59, including interest.

5. *Combined Refund Plan Summary*

We propose a combined refund for property tax, Incentive Compensation Plan, Capital True-up, and NOL where the refund amounts would first each be allocated to class, with each class's allocation combined to determine a separate credit factor for each class. We will refund customers based on their 2022 calendar-year kWh usage. Customers with 2022 usage that are no longer active at the time we implement the refund and having a balance of \$2 or more will receive a check. The combined refund would appear as a single line item on customers' billing statements.

The following table summarizes the characteristics of each component of the proposed combined residential customer refund.

Attachment G to this annual report provides the total amounts to be allocated to each customer class for the combined refund.

6. *Timeframe*

We plan to include the anticipated fourteenth Department of Energy (DOE) settlement payment expected in fourth quarter 2023 or first quarter 2024¹⁰ as another element of the combined refund. We will provide an update in the DOE settlement

payment compliance filing notifying the Commission of the receipt of the payment, modifying the bill message below, providing implementation timing, and updating the refund attachments to include the DOE settlement payment. This will allow for currently approved refunds and those with scheduled implementation processing dates to be completed according to our commitments in various related proceedings. We will also file a compliance report summarizing the results of the combined customer refund within 30 days of completing the refund process.

7. *Bill Message*

The Company proposes that the following message for all customer classes be included on bills. We will work with the Commission's Consumer Affairs Office to finalize the bill message in advance of implementing the combined refund.

Your bill this month includes a refund due to lower actual property tax owed by Xcel Energy for 2022, lower employee incentive compensation for 2022, lower capital-related revenue requirements and a lower deferred tax asset increase per the MN Public Utilities Commission. Your refund appears on your bill as "Elec Combined Refund CR".

We have electronically filed this document with the Minnesota Public Utilities Commission, and copies have been served on the parties on the attached service lists.
