REFUND PLAN

Dear Mr. Seuffert:

Northern States Power Company, doing business as Xcel Energy, submits to the Minnesota Public Utilities Commission (Commission) notification for the receipt of the fourteenth payment from the United States Department of Energy (DOE) and customer Refund Plan.

The Commission issued an Order in Docket No. E002/M-21-815 on April 20, 2022 guiding the disposition of future DOE settlement payments, which is detailed below. We provide the following information to facilitate the Minnesota Department of Commerce's review and feedback on our proposed Refund Plan.

The Company proposes returning the fourteenth DOE settlement payment to our Minnesota electric customers in a combined refund with the 2022 true-ups for 2022 Property Tax, Incentive Compensation Plan, Capital True-Up, and Net Operating Loss (NOL) as presented in our November 3, 2023 Combined Refund Plan.¹ This approach is consistent with the combined refund implemented for the thirteenth DOE settlement payment and 2021 true-ups.

On November 20, 2023, the fourteenth DOE settlement payment was received in the amount of \$16,781,605 for the period January 1, 2022 to December 31, 2022. The allocation to our Minnesota electric customers is \$12,258,817; this amount will be returned to our Minnesota electric customers.

The Company has placed these funds into a separate external interest-bearing account and will include the interest minus bank fees, in calculating the estimated amount of the proposed credit to customers. Upon Commission approval of our 2022 Property Tax, Incentive Compensation Plan, and Capital True-Up along with the NOL results, the Company will combine the refunds due to our Minnesota electric customers with the fourteenth DOE settlement payment.

I. BACKGROUND

A. 2011 Settlement

Under the Nuclear Waste Policy Act, utilities such as Xcel Energy were required to enter into contracts for the disposal of spent nuclear fuel; utilities contribute 1.0 mil for every kilowatt-hour of electricity generated by their nuclear power plants. In exchange, the DOE committed to take title to, transport, and dispose of the spent nuclear fuel beginning no later than January 31, 1998. However, the DOE has not accepted any spent nuclear fuel to date.

In 1998, the Company filed the first of two lawsuits against the DOE seeking to recover damages associated with storage of spent nuclear fuel at our Prairie Island and Monticello nuclear generating plants. The Company's claims were for partial breach of the Standard Contract for Disposal of Spent Nuclear Fuel for failing to take title to, transport, and dispose of spent nuclear fuel beginning no later than January 31, 1998. The first lawsuit sought damages through 2004; the second sought damages through 2008.

The Company reached a settlement with the U.S. Government on these lawsuits on July 7, 2011. The settlement provided a mechanism for the Company to recover its spent nuclear fuel storage damages through December 31, 2013. On August 5, 2011, the Company filed a petition for approval of a credit mechanism to return the settlement amounts to customers in Docket E002/M-11-807.

B. Extended Settlement Agreement

The Company and the Government reached an agreement on January 24, 2014, to extend the 2011 settlement agreement for the recovery of spent fuel storage damages for the three-year period of 2014 through 2016. On December 1, 2014, the Company submitted a compliance filing in Docket No. E-002/M-11-807, which notified the Commission of this extension and that any future payment amounts would be based on the submission of damage claims and subsequent negotiations between the parties.

C. Second Extension of Settlement Agreement

On February 23, 2017, the Company and the U.S. Government agreed to extend the settlement another three years to allow for recovery of damages through December 31, 2019 (Payments 9, 10, and 11).

D. Third Extension of Settlement Agreement

On August 24, 2020, the Company and the U.S. Government again agreed to extend the settlement an additional three years to allow for the recovery of damages through December 31, 2022 (Payments 12, 13, 14). The twelfth and thirteenth payments were received on October 27, 2021 and January 3, 2023, respectively.

The fourteenth DOE payment in the amount of \$16,781,605 was received on November 20, 2023. Attachment A is a copy of the Automated Clearing House (ACH) payment confirming the amount received and has been redacted to remove Company-sensitive banking information. Attachment B provides a derivation of the Minnesota jurisdictional portion of \$12,258,817, along with the estimated credit by customer class. This payment was placed into a segregated bank account established specifically and solely for the settlement proceeds similar to the Company's treatment of the previous proceeds under the 2011 settlement agreement and extended settlements. Attachment C provides a summary of the Minnesota jurisdictional portion of all the DOE payments received to date.

II. CREDIT MECHANISM AND PLAN

A. Commission Orders

The Commission's April 20, 2022 Order in E002/M-21-815 stipulated the process to return future Settlement payments to customers:

4. Required Xcel, for the 2022 settlement payment and all subsequent DOE settlements, to file its refund plan within 35 days of the receipt of the DOE Settlement. If the Minnesota Department of Commerce (Department) does not make an objection within 35 days of the filing of the plan, Xcel shall proceed with the refund as outlined in the plan. If the refund is not issued within six months of receipt of the funds, interest will increase to the prime rate as defined in Minn. R. 7825.2400, subp. 16, after that six-month period. Within 35 days of the refund completion, the company shall make a compliance filing noting the completion and detailing the final refund amounts.

B. Credit Plan and Implementation

The Company proposes returning the fourteenth DOE settlement payment to our Minnesota electric customers in a combined refund with the 2022 true ups for 2022 Property Tax, Incentive Compensation Plan, Capital True Up, and NOL. This approach is consistent with the method used for the thirteenth DOE settlement payment and 2021 true-ups for Property Tax and Annual Incentive Compensation.² In addition we note the fourteenth DOE settlement payment is for damages incurred in 2022, aligning with the true-ups.

1. Allocation to Customer Classes

In the 2022 Property Tax True Up Docket,³ we proposed a combined credit to Minnesota electric customers where the refund amounts for property tax, incentive compensation, capital true-up, and NOL would each first be allocated to class, with each class's allocation combined to determine a separate credit factor for each class. Likewise, we would first allocate the DOE funds to class. Once the credit amounts have been allocated to each customer class, a credit factor will be calculated for each customer class based on the 2022 actual kWh usage. The appropriate credit factor will then be applied to customers' 2022 actual kWh usage to determine the actual credit amount for each customer. Customers with 2022 usage that are no longer active at the time we implement the refund and having a balance of \$2 or more will receive a check. The combined refund would appear as a single line item on customers' billing statements.

Please see Attachment D for an update to the combined refund information provided in our November 3, 2023 Combined Refund Plan in the property tax, incentive compensation, capital true-up and NOL proceedings that includes the estimated average refund per customer-by-customer class.

Table 1 summarizes the characteristics of each component of the proposed combined residential customer refund.

Attachment D to this annual report provides the total amounts to be allocated to each customer class for the combined refund.

2. *Proposed Bill Message*

We propose the following bill message be included on customer's bills and will work with the Commission's Consumer Affairs Office to finalize the message:

Your bill this month includes a refund due to lower-than-expected expenses for the following: property tax owed by Xcel Energy, employee incentive compensation for 2022, capital investments, a deferred tax asset associated with Xcel Energy's 2010 rate case, plus interest, and a settlement payment for damages related to nuclear fuel storage per the Minnesota Public Utilities Commission. Your refund appears on your bill as "Elec Combined Refund Credit".

The combined refund would appear as a single line item on customers' billing statements.

3. *Interest*

The Company has placed the funds from the fourteenth DOE settlement payment in a separate interest-bearing account to ensure the funds are accurately accounted for

pending the actual bill credit. The Company explained in its January 5, 2023 Compliance Filing in Docket Number E002/M-21-815 that, pursuant to Order Point 3 of the Commission's April 20, 2022 ORDER, based on the current balance in the DOE account, which is between \$0 and \$50 million, the Company would use the highest interest rate quoted, 3.83 percent, when issuing the fourteenth DOE settlement payment to customers. Per Order Point 4 of the April 20, 2022 Order, if the refund is not issued within six months of receipt of the funds (May 20, 2024 for the current payment), interest will increase to the prime rate as defined in Minn. R. 7825.2400, subp. 16, after that six-month period.

At the time of implementation, the DOE credit amount would include the applicable interest earned per Commission Order minus any bank fees or charges on these funds, consistent with the previous one-time DOE settlement credits.

4. Implementation and Compliance Filings

Assuming the Department does not object to our Combined Refund Plan and, we estimate beginning implementation in the second quarter of 2024 for the one-time bill credit, including a bill message, based on the customers' 2022 usage. The Company will submit a compliance filing within 30 days after completion of this bill credit, providing a summary of the final credit amounts, interest, class allocations and the actual average customer credit per customer class as was done with previous DOE settlement payments, property tax, incentive compensation refunds, capital true-up, and NOL refunds.
