



Green Energy is not only the right thing to do for the environment; it provides a competitive economic advantage to the host geographic area.

The 100 MW Aurora Solar Project has a number of significant advantages:

- a. The development will take place in 25 sites. The distributed structure will allow the locally-produced energy to remain in the community which will reduce the need for additional/upgraded transmission lines—reducing eventual cost to the end-user.
- b. The total project will produce approximately 800 construction jobs and 30 long-term jobs. More importantly, the availability of the ready supply of predictably priced energy will allow for the economic development growth of the subject areas.
- c. There is an estimated production tax revenue yield of \$9,600/year per four MW site.
- d. The anticipated growth producing energy would be available with low impact and minimal consequences. Energy produced by solar power produces zero pollutants, zero carbon dioxide, nitrous oxide, particulate matter, VOCs, sulfur dioxide or mercury.
- e. Minimal residual impact—when the solar farm is past its useful life, it's as simple as removing the posts to convert the land back to agricultural utilization.


