Dear Dr. Haar:

The Minnesota Department of Commerce, Division of Energy Resources (Department) filed its *Comments* in this docket on June 27, 2013. In those *Comments*, the Department recommended that the Minnesota Public Utilities Commission (Commission) accept Greater Minnesota Gas's (GMG or Company) 2012 *Annual Service Quality Report* pending the Company's response to various inquiries and the provision of additional information in *Reply Comments*.

Specifically, the Department requested that the Company provide the following in *Reply Comments*:

- a full explanation of why the percentage of meters read by utility personnel decreased from 2011 to 2012;
- an explanation of why the level of involuntary disconnects significantly increased in 2012;
- clarification and/or explanation of how complaints are determined, and classified, by call center personnel and whether the Company is able to provide complete complaint data.

GMG filed its *Reply Comments* on July 5, 2013. In its *Reply Comments*, the Company provided additional, clarifying information regarding the issues the Department identified in its *Comments*. The Department appreciates the additional information and concludes that the Company's explanations and clarifications are satisfactory. The Department recommends that the Commission accept GMG's 2012 *Annual Service Quality Report*.

The Department does not anticipate filing any additional comments in this docket and is available to answer any questions that the Commission may have.
