The Minnesota Department of Commerce, Division of Energy Resources (Department) filed its *Comments* in this docket on June 27, 2013. In those *Comments*, the Department recommended that the Minnesota Public Utilities Commission (Commission) accept Minnesota Energy Resources Corporation's (MERC or Company) 2012 *Annual Service Quality Report* pending the Company's response to various inquiries and the provision of additional information in *Reply Comments*.

MERC filed its *Reply Comments* on July 8, 2013. In its *Reply Comments*, the Company provided additional, clarifying information regarding the issues the Department identified in its *Comments*. The Department appreciates the additional information and concludes that the Company's explanations and clarifications are generally satisfactory.

On the specific issue of the residential explosion that occurred on September 15, 2012, the Company was unable to provide the additional information that the Department requested due to the fact that the investigation is still ongoing. The Department recommends that the Commission require MERC to file an update in this docket on the outcome of the investigation.

In conclusion, the Department recommends that the Commission accept MERC's 2012 *Annual Service Quality Report* and require that the Company file an update in this docket at the conclusion of the investigation of the September 15, 2012 residential explosion. The Department does not anticipate filing any additional comments in this docket and is available to answer any questions that the Commission may have.
