Minnesota Energy Resources Corporation, a subsidiary of Integrys Energy Services, Inc., is a natural gas company providing service to approximately 216,000 customers in 49 counties and 165 communities across Minnesota. If the Commission approves the sale, Alliant Energy will no longer provide natural gas service in Minnesota. Alliant Energy's Minnesota customers will be transferred to MERC.

If the transfer is completed, MERC proposes to begin billing Alliant Energy's Minnesota customers according to the MERC rates in effect at that time. MERC's rates are higher than Alliant Energy's current rates.
