Project Description: On January 15, 2015, Great River Energy and Minnesota Power filed a combined certificate of need and route permit application with the Minnesota Public Utilities Commission (Commission) to construct a new 22.5 mile, 115 kV overhead transmission line and three associated substations in Hubbard, Wadena and Becker counties, Minnesota.
