ELECTRIC SERVICE AGREEMENT AMENDMENT

Dear Mr. Wolf:

Northern States Power Company, doing business as Xcel Energy, submits these Comments in response to the Minnesota Public Utilities Commission's Notice of Comment Period dated January 27, 2015.

We appreciate the opportunity to comment on whether the Commission's decision on the agreement should apply only to the individual agreement in this docket, or should be ruled on more broadly as a template to be used with other customers.

We think this contract could reasonably be applied to other similarly situated customers, and we do not oppose treating this contract as the basis for a template until a final tariff is approved. Creating a template could aid in setting expectations for customers who seek a net metering arrangement for distributed generation on a premise with a single system 40 kW or larger, but less than one MW, in the interim period prior to the resolution of the Commission's rulemaking and approval of the Company's tariff in compliance with the rules.

We believe the contract is in the public interest, and we look forward to the Commission's review of our proposed contract amendment.
