Incentive Compensation Refund Mechanism Compliance Filing

Dear Dr. Haar:

On July 13, 2012, the Minnesota Public Utilities Commission (the Commission) issued its Findings of Fact, Conclusions and Order in the above referenced matter. The Commission's Order required that MERC shall refund any incentive compensation costs included in the test year revenue requirement that are not paid out in a particular year. MERC may track the annual amounts to be refunded and make the refunds only after they reach \$1.00 per customer. Order Point 9.B requires that MERC make an annual compliance filing within sixty days after the incentive compensation awards are or would have been paid. The Order requires that MERC include sufficient information to determine whether a refund is required and, if so, the amount of the refund.

MERC submits this filing in compliance with Order Point 9.B of the Commission's July 13, 2012 Order. Attached is MERC's 2013 Incentive Tracker. For 2013, the annual amount to be refunded did not exceed the \$1 per customer threshold and MERC, therefore, did not make a refund to its customers. The \$91,294.00 cumulative underpayment of incentive payout was booked as a regulatory liability account to be refunded when the \$1.00 per customer threshold is met.
