The Chamber supports Hon. Lipman's recommendation that the Commission, "at the

very least consider clarifying the scope of its decision-making under Minn. R. 7853.0130."3 The

Chamber supports a process that is clearly defined, allows for public participation that assists the

Commission in making informed determinations, and makes efficient use of government and

party time and resources. ⁴ As a party to this proceeding, this process was unnecessarily difficult

and expensive. Moreover, it was our experience during the CN proceeding that the decision to

bifurcate the proceeding led to more confusion among members of the public and even at times

parties represented by counsel.

For the aforementioned reasons, the Chamber does not have any exceptions to file and

supports the Recommendation and urges the Commission to grant the requested Certificate of

Need.
