Dear Mr. Wolf:

I am writing today on behalf of the Saint Paul Area Chamber of Commerce. We are one of the State's largest Chambers of Commerce and our mission is to serve and advocate on behalf of the business community across the East Metro.

It has come to our attention that the Community Solar Garden program launched late last year by Xcel Energy has the potential to increase energy rates on our members who are not participating in a Solar Garden. We note with interest the statements of the Office of Attorney General which cite dramatic levels of customer impact that will result if this program is not fixed.

The Office of Attorney General points out the subsidy that flows between customers as a result of the program. They state, "the scale of the proposed CSG projects proposed thus far affords large companies the opportunity to offset their entire energy use and receive a bill credit that is currently designed to be greater than their full retail rate. The impact of this is that these subscribers may receive bill credits that are equal to, or possibly greater than their electric bills— and all of those costs would be paid for by Xcel's other ratepayers. The result is a direct subsidy from non-participants to pay for the program. "

We urge the Commission to consider working with all parties involved to enforce the 1 MW limit on gardens to make sure the program is implemented correctly and does not unfairly raise rates on our members who do not choose to participate in these gardens.

Our organization supports efforts to add energy opportunities and green energy now and in the future for our businesses and community. However, these efforts and initiatives need to be done in such a way that they are fair to our businesses and stakeholders and do not place a burden on one for the benefit of another.

In reviewing documentation on the Community Solar Garden (CSG) program, the costs of these appear to be at the expense of others - especially for commercial and industrial properties as they use more electricity than residential customers and their rates tend to be greater than their cost of service.

The Chamber is in support of the Minnesota Chamber's position that the Commission, Xcel, and other stakeholders will work on creating a system that advances CSG's, but does so in a way that does not force other customers to subsidize CSG participants and that any new solar resources are acquired at the lowest cost possible.

Dear Public Utility Commission Members;

It has come to my attention that the current state of the community Solar Garden program could increase rates to Xcel ratepayers. Some estimates place that number at approximately \$60 million annually. For some Xcel customers that could result in a 6% increase in their energy costs. This increase directly impacts job growth and business expansion. Commercial and industrial customers typically use more electricity than residential users.

We encourage the expansion of alternative energy sources as a sound energy policy. Furthermore, the Community Solar Garden program as originally intended was a worthwhile endeavor. However, certain developers want to establish up to 40 1MW gardens next to each other. That seems to be a loophole not originally intended. We are concerned that this loophole will result in unintended higher electrical rates for our members. If the intent is to expand solar energy use we suggest researching if solar resources could be acquired from Xcel at a lower rate.

The White Bear Area Chamber urges the Utility Commission to seriously take our comments into account. Customers should not be forced to subsidize the Solar Garden proposed large scale projects. New solar resources should be acquired at the lowest cost possible rate. In our opinion; that will encourage more competition in the use of alternative energy. That competition will drive down prices and ultimately encourage greater use of solar energy

The Metropolitan Council (Council) appreciates the opportunity to submit Reply Comments in response to the Minnesota Public Utilities Commission's (Commission) May 18, 2015 Notice of Comment Period on Northern States Power Company's, dba Xcel Energy (Xcel or the Company), April 28, 2015 filing, and in particular to discuss the impact on the Council's constituencies

1. CSG and Financial Impact:

Differentiating regional cost/value from ratepayer impact is necessary, so as not to over burden ratevulnerable electric ratepayers - especially those for which electricity is a big part of their household income and for trade-sensitive industries.

The benefits of solar to the grid and regional externalities as determined in the "Value of Solar" findings make clear the value of solar to the region. Moreover the reasoning around the state solar mandate and goal and the need for carbon and particulate matter emissions reductions further the desirability of solar development in the region.

As one of Xcel's largest Minnesota customers, we acknowledge that this CSG program does potentially mean a small adverse impact to rates for Xcel customers (as compared to larger competitive solar procurements without prescribed credits) and so some limits may be warranted. However, the societal benefit of solar in general is compelling and we suggest holding off on restrictions until Xcel has large scale solar proposals in hand and the incremental cost is clear.

2. CSGs and Council Facilities

Although the Council has opportunities to connect solar facilities directly to its facilities, those opportunities are often limited for technical or operational reasons.

Community Solar Gardens are an effective tool to help the Council bypass these limitations while contributing to the promotion of renewable energy in Minnesota. As we have discussed with the PUC. the Council has buffer land around its wastewater treatment plants well suited for Community Solar Gardens. Other marginal public land such as closed landfills, on brown fields, or around transportation corridors, are also an opportunity for a beneficial use of land that may otherwise not be used to its potential. Allowing multiple or bigger gardens on this land also allows for economies of scale and better

pricing benefitting for the public – who really are the communities. So if the public pays a bit more they get it back in another form. For example, better CSG subscription prices helps the Council maintain its competitive wastewater user fees which are good for the entire regional economy. We suggest consideration of a marginal public land exception to any eventual limitations.

Also, it is important to note that the Council and our rate and taxpayers will potentially be damaged if Xcel does not timely process garden applications, and move projects through the interconnection queue. We have projects in the queue, more for which proposals were received (after 2 years of effort) and another RFP, expected to be issued in July, in development with months or years of expenses by multiple parties. If changes are allowed to the interpretation of the rules, we request these projects be grand-parented and proceed under the original rule interpretation.

The Metropolitan Council appreciates this opportunity to submit *Reply Comments* and would be happy to participate in further discussion of the matter.

On behalf of the 1,050 business members of our Chamber, we urge careful consideration of Xcel's March 4, 2015 Reply Comments submitted in this docket. We stand by Xcel's point that "there is a way to strike the right balance between moving forward with community solar garden projects while recognizing that approving utility scale projects at CSG rates is not in the best interest of our customers or sustainable for the long term."

The St. Cloud Area Chamber of Commerce hopes the Commission, Xcel and other stakeholders will work together to create a system that advances CSG's, but does so in a way that does not force other customers to subsidize CSG participants and ensures that any new solar resources are acquired at the lowest cost possible, given the status of solar technology. Such an approach should implement the CSG program without further eroding the competitiveness of Xcel and other affected utilities' rates.
