REPLY COMMENTS OF THE OFFICE OF THE ATTORNEY GENERAL

I. INTRODUCTION

The Office of the Attorney General – Residential Utilities and Antitrust Division ("OAG") submits the following Reply Comments in response to the Comments filed by the Department of Commerce, Division of Energy Resources ("the Department") on August 13, 2015, and pursuant to the Public Utilities Commission's ("the Commission") August 4, 2015 Notice of Comment Period on Completeness and Procedures. Specifically, the OAG is responding to the Commission's inquiries as to whether CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Minnesota Gas' ("CenterPoint") Application to Increase Natural Gas Rates filed on August 3, 2015 ("Petition") complies with applicable filing requirements and Commission Orders, and whether this matter should be sent to the Office of Administrative Hearings for a contested case hearing.

II. CENTERPOINT'S PETITION FAILS TO COMPLY WITH PAST COMMISSION ORDERS.

The OAG concurs with the Department's conclusions regarding CenterPoint's Petition's failure to comply with past Commission Orders. Specifically, CenterPoint failed to comply with

Commission Orders by failing to explain and justify the methodology for classifying and allocating its sales expenses and regulatory commission expenses as part of its class cost of service study as ordered in its 2013 Rate Case.¹ The Commission should not find that CenterPoint's Petition is complete unless and until CenterPoint identifies where it has explained and justified its classification and allocation of sales expenses and regulatory commission expenses or provides additional testimony to bring its Petition into compliance with the Commission's previous Order. At that time, the Commission should revise the completeness date of the rate application.

III. IF AND WHEN THE COMMISSION FINDS THAT CENTERPOINT'S PETITION IS COMPLETE, IT SHOULD REFER THE MATTER TO THE OFFICE OF ADMINISTRATIVE HEARINGS FOR A CONTESTED CASE HEARING.

CenterPoint's Petition includes thousands of pages of testimony and supporting documentation addressing a wide range of topics, including debt and equity costs, capital structure, numerous categories of expenses, weather patterns, and rate design. The complexity and breadth of the filing ensure that the discovery process and analysis by the OAG and Department staff will identify contested issues of material fact² which could most efficiently and effectively be resolved in a contested case hearing. Therefore, if and when the Commission
