Dear Mr. Wolf:

Following Minnesota Rule 7843.0500, Subp. 5, Great River Energy ("GRE") hereby submits a Notice of Changed Circumstance in our current Integrated Resource Plan ("IRP"). I am writing to inform the Commission and other parties of a recent transaction that affects GRE's capacity position over the next four years.

GRE has entered into an agreement under which GRE will sell 50 megawatts ("MW") of MISO Zonal Resource Credits for the MISO Planning Years of 2016/17 through 2019/20 to Minnesota Power. This is a capacity only agreement and does not include energy. The sale results in a 50 MW reduction in our projected Load and Capability position in each year over the four years of the agreement.

This sales agreement does not have an impact on GRE's Preferred Plan in our IRP.
