Northern States Power Company, doing business as Xcel Energy, submits this report to the Minnesota Public Utilities Commission in compliance with the Company's Business Incentive and Sustainability (BIS) Rider as approved by Order Point 33 of the Commission's September 3, 2013, FINDINGS OF FACT, CONCLUSIONS AND ORDER in Docket No. E002/GR-12-961.

The Company's BIS Rider tariff requires that the Company ... file a report with the Commission identifying the number of customers receiving service under this Rider and the associated incremental additional revenues received by the Company and the incremental additional costs experienced by the Company.

One customer, Rosemount, Inc. (Emerson), is receiving service under this Rider. The incremental revenues the Company received and the incremental costs experienced due to Rosemount, Inc. receiving service under this rider are shown on Attachment A.

May 2015 was the first month that Rosemount, Inc. received service under the BIS Rider. Attachment A shows the revenues and costs for May-October 2015. In our initial analysis provided in Attachment B of our April 16, 2015 Compliance Filing, we assumed Rosemount, Inc. would be on the General Time of Day Service Rate Code A15, however the customer qualifies for, and has chosen to be, on our General Service Rate Code A14 and was billed accordingly. If the customer's load changes and they require a different rate code, we will work with the customer to make those

updates and reflect that in a future annual BIS rider report. There were no additional distribution costs or capacity costs associated with serving Rosemount, Inc.

Attachment A contains trade secret information as defined by Minn. Stat. (13/37(1)) (b). This information contains usage and pricing data that derives independent economic value from not being generally known or readily ascertainable by others who could obtain a financial advantage from its use. Based on that, the Company maintains this information as trade secret.
