Dear Dr. Haar:

On June 4, 2003, the Minnesota Public Utilities Commission (MPUC or Commission) opened an investigation into whether the fuel clause adjustment (FCA) continues to be a useful regulatory tool. On February 19, 2004, Dakota Electric Association (Dakota Electric) submitted comments in this matter, with additional comments provided on April 27, 2007. On August 16, 2007, the Commission solicited additional comments in this matter.

Dakota Electric submits this filing to confirm that we continue to stand by previous comments as submitted on February 19, 2004 and April 27, 2007. Specifically, through these prior comments, Dakota Electric has shown that wholesale power costs represent an important cost of providing service to our members, and the original reasons for implementing automatic energy adjustments are just as valid today as they were when the electric energy adjustment rules were originally established. Based on the details provided in these earlier comments, Dakota Electric continues to request a Commission finding that our continued application of the Resource and Tax Adjustment is appropriate and in the best interest of our member-owners. We further request that Dakota Electric be removed from any further investigation that the Commission may decide to undertake in this docket.
