## Background

On June 4, 2003, the Commission opened an invesigation into whether the fuel clause adjustment (FCA) continues to be a useful regulatory tool. On December 19, 2003, the Commission solicited comments on the purpose, structure, and rationale of the current FCA. Parties filed comments during 2004 in response to the Commission's solicitation.

On March 30, 2007, the Commission issued another Notice for Comments to allow parties to comment and update the record. Parties filed additional comments.

On July 27, 2007, the Department of Commerce (DOC) filed comments recommending that the Commission allow parties to file additional comments to update the record and to clarify what issues remain relevant to this investigation.


