OTTER TAIL POWER COMPANY ADDITIONAL INITIAL COMMENTS

I. INTRODUCTION

On November 19, 2014, the Minnesota Public Utilities Commission ("Commission") filed a Notice of Additional Comment Period in the above captioned Docket. Otter Tail Power Company ("Otter Tail") submits these Additional Initial Comments to address the following questions raised by the Commission in its November 19 Notice:

Topic/s Open for Comment:

- Should the Commission accept the electric utilities 2012-2013 annual automatic adjustment reports?
- Should the Commission adopt the recommendations in the Department's September 16, 2014 review of the 2012-2013 annual automatic adjustment reports?
- Should the Commission adopt the recommendations in the OAG-AUD's September 26, 2014 comments?
- Any other issues parties consider appropriate.

II. RESPONSES TO TOPICS OPEN FOR COMMENT

Should the Commission accept the electric utilities 2012-2013 annual automatic adjustment reports?

Yes. Otter Tail has complied with all of its reporting requirements for the 2012-2013 annual automatic adjustment report ("AAA") through its Initial Filing in this Docket and Reply Comments submitted November 10, 2014. Otter Tail requests approval of its 2012-2013 AAA report.

Should the Commission adopt the recommendations in the Department's September 16, 2014 review of the 2012-2013 annual automatic adjustment reports?

The Minnesota Department of Commerce, Division of Energy Resources ("Department") noted in Sections I and II of their September 16, 2014 Comments that the utilities have filed the information necessary to meet their filing requirements. Otter Tail agrees with the Department's recommendation to accept the compliance filings for Section III, A to N as applicable to Otter Tail. The Department also confirmed that the utilities complied with MISO Day 1 reporting requirements in Section VII.

In Section VIII, the Department requested additional information from Otter Tail with regard to Otter Tail's MISO Day 2 reporting. Otter Tail responded to the Department's request, providing that information in Reply Comments filed November 10, 2014. Otter Tail has addressed the Department's questions in its November 10, 2014 Reply Comments and requests Commission approval of Otter Tail's MISO Day 2 reporting.

Lastly, Otter Tail agrees with the Department's recommendation that the Commission accept Otter Tail's Ancillary Services Market ("ASM") reporting, as summarized in Section IX.

In summary, Otter Tail requests that the Commission adopt the Department's recommendations as they pertain to Otter Tail's 2012-2013 AAA report. Otter Tail also requests Commission approval of Otter Tail's MISO Day 2 reporting.

Should the Commission adopt the recommendations in the OAG-AUD's September 26, 2014 comments?

These Comments are not applicable to Otter Tail Power.

Any other issues parties consider appropriate?

Otter Tail does not have any other issues to address at this time.
