Dear Mr. Wolf,

On February 12, 2016, CenterPoint Energy (the "Company") petitioned for approval of a Continued Variance from the Commission's Automatic Adjustment Rules to the Recovery of Demand Costs.

On April 13, 2016, the Department of Commerce, Division of Energy Resources (the "Department") filed Comments regarding the Company's petition. The Department recommends that the Minnesota Public Utilities Commission grant the requested variance to Minnesota Rule 7825.2700 subp. 5 for three years; allow the Company to continue to calculate a monthly demand adjustment to the Company's demand-cost recovery rate as approved in Docket No. G-008/M-07-1063 and updated in Docket No. G-008/M-13-728, including the provision regarding capacity-release credits and removal of the one-month lag; continue to cap the maximum monthly allowed demand adjustment at 25 percent of the demand cost recovery rate; and continue to require the Company to report information pertaining to the operation of the program.

The Company appreciates the analysis and Comments provided by the Department and supports the recommendation outlined in the Department's analysis.
