Dear Mr. Wolf:

Great River Energy, on behalf of Great River Energy and Minnesota Power ("Permittees"), submitted a request for two minor alterations of the route on May 12, 2016. On May 26, 2016, the Minnesota Department of Natural Resources ("DNR") submitted comments in which it expressed concerns about Minor Alteration 2; DNR had no comments regarding Minor Alteration 1. On June 1, 2016, the Minnesota Public Utilities Commission ("Commission") issued a notice accepting comments concerning the minor alteration requests until June 16, 2016. On June 8, 2016, Great River Energy requested that the Commission defer consideration of Minor Alteration 2 pending further consultation with DNR.

Earlier today, Great River Energy met at the alternative substation site with DNR representatives. Our understanding is that DNR has determined the proposed site is disturbed and that, with limited mitigation, the substation can be constructed as proposed in Minor Alteration 2 without resulting in significant changes in the human or environmental impact of the facility. We have been advised that DNR will be separately submitting comments regarding mitigation. Based on the outcome of this meeting, Great River Energy respectfully requests that the Commission proceed with its consideration of both minor alteration requests.
