Topics Open for Comment:

- Whether the reports contain all information required by the Commission in its Order, issued April 25, 2014, in Docket No. E-999/CI-13-542, and the Commission's Order, issued October 23, 2014, in Docket No. E-999/M-14-321.
- Whether the reports contain sufficient information to enable commenters and the Commission to determine if Xcel Energy, Minnesota Power, and Otter Tail Power Company have plans to meet the Small Solar Carve Out of the SES.
- Any other issues of interest to commenters.

Project Background: In an Order issued April 25, 2014, in Docket No. E-999/CI-13-542, the Commission established content requirements for utilities' annual Solar Energy Standards (SES) reports. The first reports were received in Docket No. E-999/M-14-321 and in an Order issued October 23, 2014, the Commission established additional content requirements for the annual SES reports.

Filing Requirements: Utilities, telecommunications carriers, official parties, and state agencies are **required** to file documents using the Commission's electronic filing system (eFiling). All parties, participants and interested persons are encouraged to use eFiling: mn.gov/puc, select *eFiling*, and follow the prompts.

Submit Public Comments: Visit <u>mn.gov/puc</u>, select *Speak Up!*, find this docket, and add your comments to the discussion.
