I represent the Moorhead Public Service Commission, a municipal utility of the City of Moorhead ("MPS"). MPS is authorized, on behalf of itself and Red River Valley Cooperative Power Association (the "Cooperative") (collectively, the "Parties) to make this filing.

Summary of the Joint Request

This filing constitutes the Parties' joint request under Minn. Stat. § 216B.39, subd. 3, that the MPUC modify the Parties' service territory boundaries. This joint request concerns the transfer of an area annexed into the city limits of Moorhead and within the electric service territory assigned to the Cooperative (the "Affected Area"), as further described below.

Legal Authorities

By statute, "the commission may on its own or at the request of an electric utility make changes in the boundaries of the assigned service areas, but only after notice and hearing . . . " Minn. Stat. § 216B.39, subd. 3. In addition, "no electric utility shall render or extend electric service at retail within the assigned service area of another electric

utility unless the electric utility consents thereto in writing . . . " Minn. Stat. § 216B.40 (2014). In the present case, the Parties seek to adjust the service territory boundaries to transfer the Affected Area to MPS' assigned service territory. The Parties have agreed upon appropriate compensation. The Parties request that the Commission update its official records as to electric service territory boundaries.

Underlying Information

1. <u>Exhibit A: Affected Area.</u> Attached as Exhibit A is a map that depicts the boundaries of the Affected Area. The Affected Area involves approximately 1,061 acres. There are approximately 349 residential customers and 8 commercial customers.

2. <u>Exhibit B: Annexation Documents.</u> Attached as Exhibit B is a copy of the annexation documents for the Affected Area. The Parties have agreed to compensation for the transfer of the Affected Area, after arms-length negotiations.

The Parties do not have a separate legal description prepared of the Affected Area, but are willing to provide whatever information is helpful and reasonably requested by MnGeo to facilitate the adjustment in the official maps. The annexation documents in Exhibit B provide a legal description of the entire annexation, which includes the Affected Area as well as an area currently assigned to another service provider.

Customer Notice

The Parties communicated extensively with the customers in the Affected Area throughout the transition process. Copies of the pertinent correspondence and notices of public meetings are attached as <u>Exhibit C.</u>

The Parties acknowledge that the Commission wishes to direct separate notice to customers as to the pending proceeding before the Commission. Attached as <u>Exhibit</u> \underline{D} is a proposed notice to be sent to all customers in the Affected Area.

Anticipated Transfer Date

The Parties have enjoyed extensive technical discussions to minimize disruptions to customers and to proceed efficiently. The Parties and have determined to transfer the services in phases during the last two weeks in October.



The city resolution for orderly annexation submitted by the City of Moorhead was

and Order.

FINDINGS OF FACT

1. A joint resolution for orderly annexation was adopted by the City of

Moorhead and Oakport Township pursuant to Minnesota Statutes § 414.0325 and filed

with the Office of Administrative Hearings, Municipal Boundary Adjustment Unit.

2. A resolution adopted and submitted by the City of Moorhead requests

annexation of part of the designated area described as follows:

Tract 2

- a. The south 754 feet of the SW 1/4 of Section 16, and;
- A triangular shaped parcel described as beginning 749.7 feet north of the SW corner of Section 16, thence north 965.54 feet, thence southeasterly 228.98 feet, thence northeast 7 feet, thence south 181.53 feet, thence southeast 898.68 feet, thence west 852.56 feet to point of beginning, and;
- c. The west 1518 feet of the NW ¼ of Section 17, and;
- d. The portion of the south half of Section 17 lying north of the Red River of the North, and;
- e. The portion of Section 18 lying east and north of said river, and;
- f. The portion of Section 19 lying east and north of said river, and;
- g. The portion of Section 20 lying north and east of said river, and;
- h. The portion of the west half of Section 21 lying east of said river, and;

- i. The portion of the NW ¼ of the NW ¼ of Section 28 lying east of said river, and;
- j. The portion of the NE ¼ of the NE ¼ of Section 29 lying east of said river, and;
- k. The Palmer Nymark property in Government Lots 3 and 4 described as two parcels:
 - The first parcel described as beginning at a point 14 feet west of the Southeast Corner of Government Lot 3, thence West 200 feet on the north line of Government Lot 3, thence North 554.5 feel parallel to the east line of Section 29, thence East 200 feet to a point 14 feet west of the east line of Section 29, thence South 554.5 feet to the point of the beginning.
 - The second parcel described as beginning at the Northeast Corner of Government Lot 4, thence West 7.50 chains (approximately 495 feet) on the north line of Government Lot 4, thence S 2°45' E a distance of 8.52 chains (approximately 562.3 feet); thence N 44° E a distance of 10.04 chains (approximately 662.6 feet) to a point of intersection with the east line of Section 29, thence North 1.32 chains (approximately 87.1 feet) on the east line of Section 29 to the point of beginning, and;
- 1. The Moorhead Rod and Gun Club property described as two parcels:
 - The first parcel beginning at the Northwest Corner of Section 33, thence South 456.9 feet on the west line of Section 33, thence East 286 feet, thence North 456.9 feet to the north line of Section 33, thence West 286 feet on the north line of Section 33 to the point of the beginning.
 - 2. The second parcel described as beginning at the Northeast Corner of Section 32, thence West 254.69 feet on the north line of Section 32 to a point of intersection with the north bank of Clay County ditch 41, thence southeasterly along the said ditch bank to a point of intersection with the east line of Section 32 thence North 384.00 feet more or less on the east line of Section 32 to the point of the beginning.
- 3. Minnesota Statutes § 414.0325, subd. 1(h) states that in certain

circumstances the Chief Administrative Law Judge may review and comment, but shall

within 30 days order the annexation pursuant to the terms of a joint resolution for orderly

annexation.

4. The joint resolution contains all the information required by Minnesota Statutes § 414.0325, subd. 1(h).

NOW THEREFORE BE IT RESOLVED by the City Council of Moorhead as follows:

- This Initiating Resolution is made pursuant to Section 3 of the Joint Resolution to provide for the effective date of annexation of Tract 2 according to the terms of the Joint Resolution.
- 2. All parcels within Tract 2 will be annexed to the City of Moorhead, effective on

January 1, 2015.

- 3. A map of Tract 2 is attached as Exhibit A, the legal description of Tract 2 is attached as Exhibit B, and the Joint Resolution, as amended, is attached as Exhibit C.
- 4. Upon adoption and execution of this Initiating Resolution for the annexation of Tract 2, the City of Moorhead will file the same with the State of Minnesota's Municipal Boundary Adjustment Unit of the Office of Administrative Hearings and will comply with such requirements as may be necessary to provide for the effective date of annexation of Tract 2 on January 1, 2015.
- 5. The City of Moorhead agrees that no alteration of the stated boundaries as described in the Joint Resolution is appropriate, that no consideration by the Office of Administrative Hearings is necessary, and that all terms and conditions for annexation of Tract 2 are provided in the Joint Resolution. Pursuant to Minnesota Statutes, Section 414.0325, upon receipt of this Initiating Resolution, the Office of Administrative Hearings may review and comment, but shall within thirty (30) days order the annexation in accordance with the terms and conditions contained in the Joint Resolution.

MPS recognizes that you will incur an expense to modify your system; therefore, we are providing a special, limited-time incentive to encourage you to participate in MPS' Dual-Fuel Program.

MPS will compensate you up to \$1,600, or 80 percent of the total conversion costs, whichever is less, to modify your existing dual-fuel system to meet the requirements of MPS' Dual-Fuel Program. This special incentive is available only for dual-fuel systems that have been inspected and approved by MPS before December 31, 2016. After December 31, 2016, regular program incentives will be in effect should you wish to convert your system to meet MPS' Dual-Fuel Program requirements (typically up to \$400).

Please note that, until you modify your dual-fuel system, you will not receive the benefits of the low, dual-fuel rate offered by MPS. Also, as a reminder, you may not want to wait until fall to make arrangements with heating contractors as they will be busier at that time.

The transfer of your electric service from Red River Valley Cooperative Power Association (RRVCPA) to Moorhead Public Service (MPS) is expected to occur during the last two weeks of October 2016. As a reminder, your existing dual-fuel system will no longer operate and will not qualify for MPS' Dual-Fuel Program unless it is modified. If you choose to not modify your dual-fuel system, please ensure that your primary space heating system, regardless of the fuel source, is fully operational.

As you may know, MPS is providing special incentives for a limited time to encourage you to modify your existing dual-fuel system to qualify for MPS' Dual-Fuel Program. A Level 2 Incentive has been added for customers with higher costs to modify their system. <u>The following special incentives are available for modified dual-fuel systems that are inspected and approved by MPS before December 31, 2016.</u>

Level 1 Incentive - For existing dual-fuel systems that cost less than \$2,000 to modify.

- MPS will compensate you up to \$1,600, or 80 percent of the total costs, whichever is less, to modify your existing dual-fuel system to meet the requirements of MPS' Dual-Fuel Program.
- MPS' Dual-Fuel Program requires you to use electricity as your primary heat source.
- Your system must be inspected and approved by MPS before December 31, 2016.
- After December 31, 2016, regular incentives from MPS will apply (typically up to \$400).

Level 2 Incentive - For existing dual-fuel systems that cost \$2,000 or more to modify.

- MPS will compensate you up to \$2,800, or 80 percent of the total costs, whichever is less, to modify your existing dual-fuel system to meet the requirements of MPS' Dual-Fuel Program.
- MPS requires that you make a ten-year commitment to use electricity as your primary heat source and remain on MPS' Dual-Fuel Program.
- Early termination of your participation in MPS' Dual-Fuel Program will result in a prorated return of the incentive provided by MPS.
- Your system must be inspected and approved by MPS before December 31, 2016.
- After December 31, 2016, regular incentives from MPS will apply (typically up to \$400).

You will not receive the benefits of MPS' low, dual-fuel rate until you modify your dual-fuel system. You may want to make arrangements with heating contractors soon as the heating season is approaching. Hello Oakport Tract 2 Residents,

When I took office a few weeks ago, I began a new role as Mayor of Moorhead. This is a big change for me. But lots of other important things remain the same— I still live in the same great neighborhood with good neighbors and good friends.

I've thought about how you might feel as you approach a new role, too. ANNEXATION 1990 - 2015

 In 1990, the City of Moorhead and Oakport Township entered into a Joint Resolution for Orderly Annexation pursuant to Minnesota statutes, and the City, Township, and County entered into a Joint Powers Agreement. These documents can be reviewed at

www.cityofmoorhead.com/oakport.

- These Agreements led to the **timely** extension of wastewater and water distribution systems to Tract 2 of OakportTownship to address significant wastewater issues at that time.
- The Joint Resolution and Joint Powers Agreement outline the financing and extension of infrastructure (wastewater, water, electric) and the application of land use, zoning, subdivision, and building regulations.
- The Joint Powers Agreement established the **Oakport Joint Powers Board**, comprised of representatives from Clay County, Oakport Township, and the City of Moorhead, that has authority to make decisions with respect to land use, zoning, building regulations, extension of utility services, bike paths/sidewalks, and street design.
- The City of Moorhead currently provides the following services to Tract 2 residents: zoning, building regulations, sanitary sewer, and municipal water.
- With regard to other traditional municipal services (public safety, street and park maintenance, pest control, etc.), the Orderly Annexation Agreement states that "upon the effective date of annexation of Tract 2, Moorhead will provide municipal services, including but not limited to, fire and police protection".
- The Joint Resolution grants the City of Moorhead sole authority to enact the **initiating resolution** to complete the annexation. The annexation is scheduled to occur January 1, 2015.

SERVICE OF MORE

THE CITY OF MOORHEAD will provide municipal services in Tract 2 beginning January 1. The frequency of level of service will be the same as other areas of the City, but just as in other areas of the City, some functions may be provided by private contractors under agreements with the City, especially as we work through the initial annexation transition.

TRASH AND RECYCLING

Garbage, yard waste and branch pick up, and curbside recycling service will be provided by the City of Moorhead beginning in January 2015. You may discontinue private hauler contracts December 31, 2014. Monthly garbage service charges will be part of your Moorhead Public Service (MPS) billing.

Garbage: Household garbage is picked up weekly. A 48-gallon wheeled trash cart is provided for the base monthly collection fee; 64 and 96 gallon carts are available at higher rates. The Public Works Department will contact you in advance of the service charge for cart size preference and to let you know what your collection day will be. Special pickups can be arranged for additional fees, and you can purchase pre-paid bags for occasional use.

"Clean-Up Week" is held the first full week of May. During that time, you can dispose of furniture and many other large trash items at your curb with limited exception for no additional fee. **Recycling:** Curbside recycling is voluntary but all residential customers pay for the service. Collection is every other week on your regular trash pick-up day. Recycling bins are available on 3rd floor of City Hall for \$5.00. Recycling materials are separated within the bin by paper sacks. We'll send you additional details on schedules and what materials can be recycled before January.

Water and Wastewater: Tract 2 residents have been paying 1.5 times the City water and wastewater rates. Moorhead Public Service will continue to provide water and the City of Moorhead will continue to provide wastewater services to Tract 2 residents, but the rates will be reduced to the standard City residential rates on January 1.

Electric: Moorhead Public Service has taken initial steps to acquire the Tract 2 electric service territory from Red River Valley Cooperative and Xcel Energy; however, these current electric providers may not participate in formal negotiations until the annexation has been completed. Therefore, the buyout will likely not occur for a period of time after the annexation. Following the buyout, MPS will install new electric lines to Tract 2 neighborhoods and residences where required, utilizing existing lines as possible. MPS will be replacing existing meters with MPS meters (by appointment if the meter is located inside the home). Only Tract 2 residents who are upgrading or relocating an existing service will be required to relocate an interior meter to the outside of the house. Residents with off-peak or dual fuel systems are responsible to bring their systems into compliance with the MPS dual fuel program standards if they wish to continue with that program.

Stormwater: All City residents pay a monthly stormwater fee, currently \$10.21 per month. This fee is directed to the cost of managing stormwater runoff for flood prevention and pollution control.

The orderly annexation decision was made decades ago at a time when the City was requested to extend water and sewer services to Tract 2 in order to address some serious health issues. Now as we all prepare for the annexation to become effective, we have some work to do. Whether you have lived in Tract 2 all of this time or you moved to your home recently, you undoubtedly have questions. We have received some of these questions and we know there will be many others. City staff has prepared this "Oakport Annexation Insights" in which many of the current questions have been answered. There will be more communication moving forward, including Tract 2 neighborhood meetings, mailings, and postings to the City's website specific to annexation questions and issues.

BRANCHES/YARD WASTE

Leaves, grass clippings, and branches are picked up curbside on your scheduled garbage day, seasonally usually April through mid-November. For large volumes of yard waste, the City will maintain the existing "self-serve" Oakport compost site located off of Wall Street. You may also drop off yard waste or pick up compost or wood chips at the compost site at 1800 Hwy 75 N.

Still want to burn it? Just as it is now, burning of yard waste is allowed in some circumstances on half-acre or larger lots. Instead of getting a permit from the Dilworth Fire Department, simply get a no-cost permit from the Moorhead Fire Department so the Department is aware of open burning activities. Moorhead's full-time, full-service fire department will become the primary fire service provider in Oakport following the annexation and the City maintains mutual aid agreements with neighboring cities for additional support. The Moorhead Fire Department is discussing a possibility of "automatic aid" with Fargo Fire Department to help each city cover gaps in the future. Moorhead's Fire Department represents continued advancement in training, equipment, and service delivery for our residents.

STREETLIGHTS

Existing streetlights located within Tract 2 will be maintained. When MPS acquires the electric service territory, streetlights will be installed according to City of Moorhead policies and Minnesota Department of Transportation standards. All new streetlights will be energy efficient—LED lights that are "dark sky" compliant to reduce light pollution. **ROADS REMAIN "AS IS"**

The Annexation Agreement outlined that existing roadways will remain "as is" following annexation. County roads and bridges in Tract 2 will remain the jurisdiction of Clay County. Roadways transferred from Oakport Township to the City of Moorhead will be included in City's Capital Improvement Program for routine maintenance (wear course/ crack repair/seal coats/etc.). Future costs of major maintenance or repairs, such as paving, mill and overlay, rehabilitation, or reconstruction would be processed as special assessments as in other areas of the City only after public notice and required hearings. Street or storm drainage system changes may also be petitioned by property owners.

Existing gravel driveways will not be required to be improved with asphalt or concrete.

ALL-TERRAIN VEHICLES (ATVS) AND SNOWMOBILES

Recreational vehicles are common in Tract 2. ATVs and snowmobiles can continue to be used on private property after the annexation, and Class 2 ATVs are also allowed on shoulder areas of improved roadways (not state trunk highways—state law).

Also, the Oakport Joint Powers Board has recommended developing routes to allow snowmobiles in the ditch rightof-way of Tract 2 local roads so long as State regulations are followed.

PARKS AND TRAILS

Moorhead is committed to park and recreation opportunities throughout the City. Hopefully, you already frequent MB Johnson Park and have seen the wonderful upgrades to the park the past couple of years. There is also land dedicated for parks in Crystal Creek and North Crystal Creek subdivisions. This parkland will be transferred to the City for maintenance responsibilities at the time of annexation. The Moorhead Park Advisory Board and Plannina Commission work with neighborhoods and developments throughout Moorhead under an ongoing Capital Improvement Plan for park locations and facility improvements. Thev are looking forward to working with you on park and recreation issues. Brentwood Park is privately owned and there are no immediate plans to transfer this park to the City.

Along the Red River corridor from Tract 2 to very south Moorhead, there are new opportunities for trails and pathways following public acquisition of riverfront properties. The City of Moorhead is currently studying the Red River Corridor for opportunities for a continuous river trail and recreation nodes from

Wall Street Avenue North to 60th Avenue South. The Fargo-Moorhead Metropolitan Council of Governments is coordinating this effort. Please join in this conversation!

Trash collection/

<u>Trash Day:</u>

Tuesdays. Regular garbage will be collected weekly on Tuesdays beginning January 6. Recycling will be collected every other Tuesday beginning January 6 (Recycling route B).

Containers:

- Sign up by November 1 to select your container size (48, 64, or 96 gallon) www.cityofmoorhead.com/oakport. You'll receive an email confirmation within 48 hours of your submittal. If you do not sign up by November 1, you will receive a 64 gallon tote. Containers will be delivered by December 1. Exchange fees are \$20 for delivery and \$10 if exchanged at the Solid Waste Transfer Station. Questions? Call us at 218.299.5347
- Recycling bins are \$5 prior to October 31; price increases to \$10 on November 1, 2014. Recycling is optional but encouraged.
- **Cancel** your private garbage contract to align with the City service beginning January 6, 2015.

• **Inform** your insurance agent of the annexation and discuss how this may affect your policy rate. Some property owners may be eligible for a reduction in premium based on distance to the City of Moorhead Fire Station.

The Moorhead Police Department is currently reviewing options for limited hunting within Tract 2 following annexation.

Emergency Sirens:

Two new emergency warning sirens are planned for the Tract 2 area. Final locations are under review and the sirens are anticipated to be placed in 2015.

Street Lights:

Following acquisition of the electric service territory, Moorhead Public Service (MPS) will hold future public input opportunities regarding street lights in the Tract 2 area. After public input, a new or revised City street light policy regarding street lights in Tract 2 may be required. Based on that policy, MPS will request Moorhead City Council approval of a streetlight plan, which will include energy efficient - LED, dark sky complaint streetlight fixtures. The cost of streetlight installation is financed by the City of Moorhead and is not directly billed to Oakport Tract 2 residents.



Contraction of the

ATV & Snowmobile Usage:

Currently, snowmobiles and ATVs may be used on private property within the City of Moorhead, which will include the Oakport annexation area.

A draft ordinance is currently under review by the City Council which would enable the City Council to designate routes for operation of ATVs and snowmobiles on certain City property (which may include parks or right-of-way but not roadways). No routes have yet been designated.


