Rationale: Exhibits RHB-2, RHB-3, RHB-4, RHB-6 and RHB-8 to the Affidavit of Robert Brigham contain information that is considered Highly Sensitive Not Public because (1) CenturyLink makes reasonable efforts to ensure its privacy and (2) the data derives actual or potential independent economic value because the information is not generally known to, and not being readily ascertainable by proper means by, other persons who can obtain value from its disclosure or use. For this reason, the Exhibits RHB-2, RHB-3, RHB-4, RHB-6 and RHB-8 to the Affidavit of Robert Brigham should be protected from public disclosure.

QWEST CORPORATION DBA CENTURYLINK QC'S PETITION

Introduction

Qwest Corporation dba CenturyLink QC ("CenturyLink QC") submits this Petition under the Competitive Market Regulation provisions in newly effective Minn. Stat. § 237.025.¹ CenturyLink QC asserts that it is entitled to such regulation in each of its 108 Minnesota exchange areas because it serves less than 50% of the households and competitors offer service to at least 60% of the households in each exchange area.

Subdivision 4 of the statute sets forth two alternate tests for declaring a wire center competitive and therefore eligible for competitive market regulation:

The commission shall approve a petition under this section if a petitioning local exchange carrier demonstrates to the commission's satisfaction that:

- (1) it serves fewer than 50 percent of the households in an exchange service area, and at least 60 percent of households in the exchange service area can choose voice service from at least one additional unaffiliated competitive service provider; or
- it serves more than 50 percent of the households in an exchange service area, and:

- (i) at least 60 percent of households in the exchange service area can choose voice service from at least one additional unaffiliated competitive service provider;
- (ii) no significant economic, technological, or other barriers to market entry and exit exist;
- (iii) no single provider has the ability to maintain prices above competitive levels for a significant period of time or otherwise deter competition; and
- (iv) the petitioning local exchange carrier will continue to offer basic local service, as defined in subdivision 8, consistent with its tariffs in effect at the time of its petition.

As this Petition will demonstrate, CenturyLink QC meets the criteria set forth in Minn. Stat. § 237.025, Subd 4(1), in every Minnesota exchange it serves because CenturyLink QC:

- Serves less than 50 percent of the households in the exchange area; and
- At least 60 percent of the households can choose voice service from at least one unaffiliated competitive service provider.

The data attached to this Petition shows that in every exchange, CenturyLink QC serves less than 40% of the customers. This information alone compels a decision by the Commission to grant the Petition because at least 60% of the customers have not only service available from a competitor but have, in fact, made the decision to purchase from them. Nonetheless, CenturyLink QC offers evidence that further supports its Petition and files all of the information required by Minn. Stat. § 237.025, Subd. 2.

PROCESS

Pursuant to subdivision 3 of the statute, a party must file an objection to this Petition within 45 days, and if no such objection is filed, the "petition is deemed approved."² If an objection is filed, the Commission must provide interested parties and the petitioning carrier

an opportunity to comment on the petition.³ The Commission "shall make a final determination regarding a petition filed under this section within 180 days of the date all of the information required under subdivision 2 was submitted."⁴

Because this Petition involves competitively sensitive information and in order to ensure that potential interveners have an adequate opportunity to lodge any objections to this Petition, CenturyLink filed a proposed protective order on June 28, 2016 and recommends that the Commission approve a protective order as soon as possible so that interested parties have the opportunity to review the information filed with this Petition in time to consider any potential objection they might file.

SERVICE

Consistent with the requirements of Minn. Stat. § 237.025, Subd. 2(a), this Petition has been served on the Commission, the Office of Attorney General, all telephone companies and telecommunications carriers with whom CenturyLink QC has an interconnection agreement, and all competitive service providers identified in this Petition.⁵

REQUIRED MATERIALS FOR PETITION

Minn. Stat. § 237.025, Subd. 2, sets forth the materials that must be included in a petition. These materials are attached to the affidavit of Robert Brigham ("Brigham Affidavit"). Those materials are:

A. A list of exchange service areas in which the local exchange carrier is seeking to be regulated under this section.

See Brigham Affidavit, Exhibit RHB-1, for a list of exchange areas.

B. The local services offered by the local exchange carrier in each exchange service area;

The Brigham Affidavit, Paragraph 15, contains links to CenturyLink QC's tariffs, price lists and catalogues which list the local services the company makes available.

C. A list of competitive service providers in each exchange service area;

This list is included in the Brigham Affidavit, Paragraph 16 and Exhibits RHB-5 (wireless) and RHB-6 (Cable). As Paragraph 16 of the Brigham Affidavit explains, CenturyLink QC has identified wireless and cable providers that qualify as competitive service providers as defined in Minn. Stat. § 237.025, Subd. 1(a).

D. A description of affiliate relationships the petitioning local exchange carrier has with any provider of local service in each exchange service area;

CenturyLink QC does not have an affiliate relationship with any provider of local service that it is relying upon to demonstrate that it meets the competitive criteria in each exchange area. Brigham Affidavit, Paragraph 17. No affiliate offers residential VOIP service⁶ and any business VOIP service is provided to customers with more than three lines and is therefore irrelevant to this Petition.

E. Documentation demonstrating the local exchange carrier's loss of local voice service customers to unaffiliated competitive service providers in each exchange service area over, at a minimum, the previous five years;

CenturyLink QC has experienced significant line loss in every Minnesota Exchange since 2000. Brigham Affidavit, Paragraph 18 and Exhibit RHB-8 provide this data.

F. Evidence demonstrating that the local exchange carrier satisfies the competitive criteria under subdivision 4 in each exchange service area;

CenturyLink submits data demonstrating that "it serves fewer than 50% of the households in an exchange service area and at least 60 percent of households in the exchange

service area can choose voice service from at least on unaffiliated competitor." Under the new statute, the Commission "shall approve a petition ... if the petitioning local exchange carrier demonstrates to the commission's satisfaction" that these criteria are met.

CenturyLink offers the following data to demonstrate that it meets these standards.

1. CenturyLink QC serves less than 50% of households in each Exchange Service Area

The Brigham Affidavit, Paragraphs 5 through 7 and Exhibit RHB-2 demonstrate that CenturyLink serves less than 50% of the households in each Exchange Service Area.

One wrinkle associated with this Petition is the manner in which business customers purchasing three or less lines should be analyzed. The statute appears to exclude such data in its competitive criteria because its test analyzes the percentage of "households" served in each exchange area. However, even if one includes businesses purchasing three or fewer lines, CenturyLink serves less that 50% of such customers.

CenturyLink QC has data regarding the number of such customers that it serves.

However the census bureau does not provide data identifying the total number of businesses purchasing three or fewer lines. In order to address this issue, Mr. Brigham has assumed that CenturyLink has 100% market share for such customers. Brigham Affidavit, Paragraph 7.

Even with that assumption – which clearly overstates CenturyLink QC's market share, CenturyLink still serves less than 50% of the households in each Exchange Service Area.

Brigham Affidavit, Paragraph 7 and Exhibit RHB-3.

2. More than 60% of households have service available from a Competitive Service Provider.

Conclusive evidence also establishes that competitive service providers offer service to 60% or more of the households in each exchange service area. Brigham Affidavit,

Paragraph 9, and Exhibits RHB-2 and RHB-4 demonstrate that at least 60% of customers in every exchange service area actually receive service from a competitive service provider with the exception of one exchange – and there the percentage is 59.6%. If such a high percentage of customers actually receive service elsewhere, it is obvious that at least 60% of customers have service available and this criteria is met.

This conclusion is bolstered by wireless coverage maps discussed in Brigham Affidavit, Paragraph 10, and Exhibit RHB-5 that demonstrate wireless service is available to over 60% of customers in each exchange. Because wireless providers are specifically defined as Competitive Service Providers in statute⁹ wireless coverage alone demonstrates that the 60% threshold has been met.

CenturyLink QC further provides data regarding service offered by cable providers in Minnesota. Cable providers qualify as competitive service providers under Minn. Stat. § 237.025, Subd (1)(a)(2) because cable providers "own a substantial proportion of the last mile loop facilities delivering service to a majority of households in an exchange service area."10 Brigham Affidavit, Paragraphs 11-13 and Exhibit RHB-6, discusses this data and provides estimates from the leading provider of market share information in the industry for each wire center.

Other information requested by the commission that is relevant to the G. applicable competitive criteria under subdivision 4.

CenturyLink QC is unaware is unaware of any Commission request that additional information be filed with this Petition. CenturyLink QC stands ready and willing to provide additional information necessary for the Commission or interested parties to review the merits of this Petition through discovery responses.
