

Department Note: The Department redacted the email responses from Consolidated Telecommunications Company and TDS Telecommunications Corporation, as fiber drops and the number of customers receiving service via QC resale lines do not directly reflect the number of households in the CenturyLink exchange that may choose to receive service. CenturyLink's methodology, which assumes if a carrier provides broadband to one household in a census block, it makes voice service available to all households in the census block, will always be a greater number than actual drops or customers served.

Good morning Greg and thank you again for your help. To recap:

For the CenturyLink Brainerd exchange-In the city of Brainerd, CTC has fiber to businesses in the downtown area but voice service to households is provided using QC loops, not CTC's last mile. You believe stating that CTC offers residential voice service to [Trade Secret Data Redacted] households (using its own facilities for the last mile) in the Brainerd Exchange is more reflective of the fiber drops to residential households.

For the Little Falls exchange CTC has fiber to businesses only, no households.

CTC does not provide service in CenturyLink exchanges of Royalton, Staples, Swanville or Wayzata.

The data for Nisswa [Trade Secret Data Redacted] seems to be correct.

#### Bonnie,

I had Pam Trickel check on your questions. We can't tell you definitely how many customers we are serving in each of these 5 CL exchanges, but we can confirm that we are currently providing residential voice service to a small number of customers in these exchanges. Pam ran a report on our billing records for the cities of Buffalo, Glenwood, Nisswa, Olivia and Willmar. There very well may be additional customers in these exchanges that we are serving but that have a different "city" address other than one of the 5 listed above. Bottom line is TDS Metrocom is providing residential voice service in these exchange through resale. As you know, we are not providing service to any new residential customers, so the number of customers will not increase.
