6.8.3 <u>Bill Payment</u>

Frontier customers have the option of receiving their bills via mail or online through Frontier's online payment portal.

- a. Frontier's online payment portal enables customers to view their bills, including prior bills, check payment history, and make payments of their telephone bills online through Frontier.com or the MyFrontier Mobile app.
- b. Regulations
  - i. Online bill delivery is a discretionary Service.
  - ii. Customers opting for online bill delivery will receive an email reminder when their bill is available.
  - iii. If the customer opts to receive only an electronic bill and not a paper bill, the (N) monthly recurring charge for bill delivery will be waived.
