- Should Northwestern Wisconsin Electric Company's request to increase rates be approved?
- Should Northwestern Wisconsin Electric Company's variance requests be granted?

Project Background: On June 26, 2017, Northwestern Wisconsin Electric Company (NWEC) filed a request to increase its rates by \$2,029 or 2.668% per year. The NWEC stated that it would not implement new rates until it receives an order authorizing it to do so from the Minnesota Public Utilities Commission (Commission). NWEC made this request in this docket so that, if it is approved, the Company's Minnesota rates and rules will conform to the Company's recently approved Wisconsin rates and rules. Pursuant to Minn. Stat. § 216B.16, subd. 12a, NWEC qualifies for the small electric utility exemption from Minn. Stat. § 216B.16.

Filing Requirements: Utilities, telecommunications carriers, official parties, and state agencies are **required** to file documents using the Commission's electronic filing system (eFiling).
