PETITION FOR APPROVAL OF A TRANSFER OF PROPERTY

I. INTRODUCTION

Pursuant to Minnesota Statute § 216B.50 and Minnesota Rules 7825.1700 and 7825.1800, Otter Tail Power Company (Otter Tail) hereby petitions the Commission for approval to acquire from East River Electric Power Cooperative, Inc. (East River) certain transmission system-related substation facilities and assets on site at East River's F.L. Blair Substation located northwest of Gary, South Dakota in Deuel County, South Dakota (Blair Substation). Otter Tail submits that the proposed acquisition is consistent with the public interest, pursuant to subd. 1 of Minnesota Statute § 216B.50, for the reasons set forth in this petition. Otter Tail requests that the Commission give its consent and approval by order in writing, upon investigation without public hearing.

II. DESCRIPTION OF THE TRANSACTION

Otter Tail is an electric utility company that provides retail electric service in the states of Minnesota, North Dakota, and South Dakota. The property involved in the transaction (the Transfer) consists of 230 kV breakers, switches, current transformers, potential transformers, a terminal structure, relays, system protection & controls, and associated bus work and structural material at the site at East River's F.L. Blair Substation (Blair Substation Facilities).

The Transfer is the result of Otter Tail's contractual right and obligation to purchase the Blair Substation Facilities pursuant to Section 10 of Supplement No. 2 of an Interconnection and

Transmission Service Agreement (ITSA), dated June 10, 1983 between East River and Otter Tail. Section 10 of Supplement No. 2 of the ITSA states, in pertinent part:

"Upon termination of this contract ... Otter Tail shall have the right and obligation to purchase the facilities in the Blair Substation and the easements and other rights hereinafter described which are necessary to continue the transmission interconnection with Western [the Western Area Power Administration ("WAPA")] ... The purchase price thereof shall be the "Blair Substation Investment" less depreciation at the rate of 2.75% per year, but in no event shall the price be less than 25% of the "Blair Substation Investment" ...

In accordance with the ITSA (Supplement 2, § 10), as a result of the termination of the ITSA, East River and Otter Tail have agreed that the purchase price of the Blair Substation Facilities will be \$128,889, as determined by applying 25% to East River's "Blair Substation Investment" of \$515,554 (the original cost of the Blair Substation assets).

Closing is contingent upon final regulatory approvals of the Commission and the FERC. Otter Tail and East River presently envision closing within 30 days of these regulatory approvals.

III. COMMISSION APPROVAL

Minnesota Statute § 216B.50, subd. 1 provides in part: "No public utility shall ...acquire ... any plant as an operating unit or system in this state for a total consideration in excess of \$100,000 ... without first being authorized to do so by the commission." Section 216B.50 further authorizes the Commission to investigate an application for approval and consent without public hearing. Section 216B.50 further provides that "[i]f the commission finds that the proposed action is consistent with the public interest, it shall give its consent and approval by order in writing."

_

The original ITSA between East River and Otter Tail was signed on January 8, 1973. Supplements 1-6 were executed in subsequent years in order to address system changes and to address further expansions of the interconnections between Otter Tail and East River over time. The final such supplement to the ITS, Supplement No. 6, was signed August 16, 2011. Otter Tail provided East River with a notice of termination of the ITSA pursuant to the terms for such termination with an effective date of December 31, 2017, after which the Parties will continue their existing interconnections via separate interconnection agreements with transmission service over these interconnections arranged in accordance with the applicable Regional Transmission Organization's tariff.

Minnesota Rules 7825.1700 provides, in part: "A public utility, prior to entering into a transaction, shall petition for and receive from the commission by formal written order approval for such transaction." In the context of mergers, the Commission in 1997 established that the phrase "consistent with the public interest" under Minn. Stat. 216B.50 does not require an affirmative finding of public benefit, just a finding the transaction is compatible with the public interest. *In the Matter of the Proposed Merger of Minnegasco, Inc., Docket G-008/PA-96-950*.

In 1986 the Commission established that it has jurisdiction when property subject to a proposed transaction would be part of the integrated operating system serving Minnesota ratepayers. In the Matter of the Application of Interstate Power Company for Authority to Increase its Rates for Electric Service in Minnesota, Docket E-001/GR-86-384. This property would become part of Otter Tail's integrated operating unit or system serving customers in three states, including Minnesota.

The proposed acquisition resulting from the Transfer is compatible with the public interest because it minimizes cost impacts to Otter Tail's customers. The Blair Substation's location and connectivity to the rest of the regional transmission system will provide Otter Tail with an ownership interest and operational capability on both ends of an existing transmission outlet for one of its major generating facilities, the Big Stone Plant, providing a benefit to Otter Tail's customers. By owning and operating the Substation Assets on East River's substation site, Otter Tail will have an improved ability to manage the facilities and coordinate transmission flows over its system. The Transfer may also have the added benefit in that it will add eligibility for Otter Tail to receive facility credits from the SPP which would in turn help reduce rates for Minnesota customers of Otter Tail when credited against SPP transmission service expenses currently being accumulated in its Commission-approved SPP Tracker. Based on maintenance records provided by East River and an on-site inspection by Otter Tail, the Substation Assets are in working condition.

Minnesota Rules 7825.1800 also requires that a petition for approval of a transfer of property be accompanied by all information required in Minnesota Rules 7825.1400, items A to J, which primarily relates to capital structure approval. Otter Tail believes that it has provided all relevant information called for by Minnesota Rules 7825.1400, items A to J. At the time of filing of the petition, Otter Tail does not know of any person who is an "affiliated interest"

within the meaning of Minnesota Statutes § 216B.48, subd. 1. Furthermore, there are no securities associated with the proposed transfer of property.
