Reply Comments of Minnesota Energy Resources Corporation

On February 28, 2018, the Department of Commerce, Division of Energy Resources ("Department") submitted comments in the above-referenced docket, recommending that the Minnesota Public Utilities Commission ("Commission") approve Minnesota Energy Resources Corporation's ("MERC" or the "Company") Petition as modified in the Company's January 8, 2018, Letter regarding ANR storage; approve MERC's proposed level of demand entitlement; and allow MERC to recover associated demand costs through the monthly Purchased Gas Adjustment ("PGA") effective November 1, 2017.

MERC thanks the Department for its review and is in agreement with the Department's recommendations. Additionally, as noted in the Department's comments, MERC's November 1, 2017, filing provided cost comparison to the July 2017 PGA rather than the October 1, 2017, PGA. MERC reviewed the Department's cost comparison at Attachment 3 page 2 and confirms that comparison is correct.
