 - c. Net Plant in Service by year and on an accumulated basis from when Lake Region Energy Services began construction on their natural gas systems (Net Plant in Service = Total Plant in Service Accumulated Depreciation Deferred Income Taxes).

This filing is intended to comply with the above-stated Annual Report obligation.

- 4. Comply with Minn. Stat. § 216B.098 with respect to customer protections.
- 5. Comply with Minn. Stat. § 216B.0976 with respect to disconnections.
