Department of Commerce Energy Environmental Review and Analysis (EERA) staff reviewed the Findings of Fact, Conclusions of Law, and Recommendation (Report) issued by Administrative Law Judge Jessica Palmer-Denig (ALJ) for the Nobles 2 Wind Project. The Report provides a comprehensive analysis of the record; EERA has no exceptions to the Report.

EERA agrees with the ALJ that the Project is consistent with "the policy of the state to site LWECS in an orderly manner compatible with environmental preservation, sustainable development, and the efficient use of resources" (Minn. Statute <u>216F.03</u>).

EERA further agrees that the Public Utilities Commission should grant a Site Permit to Nobles 2 to construct and operate the up to 260 MW Project in Nobles County, and that the Site Permit include the conditions found in the Draft Site Permit, and amended as set forth in paragraph 7 of the ALJ's Conclusions of Law.
