Re: Minnesota Power's Petition for Approval of an Amendment to Electric Service Agreement Between Verso Minnesota Wisconsin LLC and Minnesota Power **Docket No. E015/M-18-603** 

Dear Mr. Wolf:

Minnesota Power provides these brief reply comments to the Minnesota Department of Commerce, Division of Energy Resources' October 17, 2018 comments (Docket No. E015/M-18-603) regarding Minnesota Power's Request for Approval of an Amendment to an Electric Service Agreement between Verso Minnesota Wisconsin LLC and Minnesota Power, specifically relating to any conflicts between the proposed Amendment to the Service Agreement and MP's tariffs.

Section III of Minnesota Power's September 21 petition filing describes how the principal terms of the Amendment integrate with Minnesota Power's Large Power ("LP") Service Schedule, and each of the subsections thereafter describe components in the Amendment and how the language in the Amendments complement that in the LP Service Schedule. Minnesota Power believes that the Amendment does not conflict with the applicable tariff or provide any conflicts between the Electric Service Agreement ("ESA") and tariffs, and has historically used that section of petitions to call out any differences that were not previously approved or any specific changes that would require specific Commission approval.

By way of example Minnesota Power does note that, while Item 3 of Section III does call out the fact that weekly expedited billing is not consistent with the existing Rider for Expedited Billing Procedures ("Rider"), weekly expedited billing was previously approved by the Commission in Docket No. E015/M-12-1025 and would presumably not require specific Commission approval again in the docket, given that the only change to the program being the removal of the financial performance criteria so that Verso will remain on weekly expedited billing for the term of the Agreement.
