Comments of the Minnesota Department of Commerce Division of Energy Resources

I. INTRODUCTION

On November 11, 2018, Plum Creek Wind Farm, LLC (Plum Creek or the Applicant) filed a *Notice Plan Petition for the Application of Plum Creek Wind Farm, LLC for a Certificate of Need for an up to 414 MW Large Wind Energy Conversion System and 345 kV Transmission Line in Cottonwood, Murray, and Redwood Counties, Minnesota.* (Notice Petition). The Notice Petition provides the Applicant's proposed Notice Plan to communicate its intent to construct a 345-kilovolt (kV) transmission line and construct associated facilities in Cottonwood, Murray, and Redwood Counties, Minnesota. According to Plum Creek, the project is required to connect a 414-megawatt (MW) wind farm located in Cottonwood, Murray, and Redwood Counties, Minnesota, to the existing Brookings to Hampton 345-kV transmission line in Redwood County, Minnesota. The Notice Petition includes a draft notice for landowners and residents, a draft notice for governmental entities, and a draft newspaper notice.

Below are the Comments of the Minnesota Department of Commerce, Division of Energy Resources, Energy Regulation and Planning Unit (Department) on the Notice Petition.

II. DEPARTMENT ANALYSIS

Minnesota Rules, part 7829.2550 state, in part:

Three months before filing a certificate of need application for a high-voltage transmission line as defined by Minnesota Statutes, section 216B.2421, the applicant shall file a proposed plan for providing notice to all persons reasonably likely to be affected by the proposed line.

Minnesota Statutes § 216B.2421 includes in its definition of a Large Energy Facility (LEF):

- (2) any high-voltage transmission line with a capacity of 200 kilovolts or more and greater than 1,500 feet in length;
- (3) any high-voltage transmission line with a capacity of 100 kilovolts or more with more than ten miles of its length in Minnesota or that crosses a state line;

Given that the Plum Creek Wind Farm is expected to require a 345-kV generation-tie line approximately 25 miles long, this associated transmission line falls within the definition of "large energy facility" and, therefore, is considered a high-voltage transmission line for which a notice plan filing is required. The Department concludes that a notice plan is required regardless of whether a certificate of need for the associated transmission line is requested through a certificate of need application for a large generating plant (as an associated facility), or whether it is requested separately.

A. TYPES OF NOTICE

Minnesota Rules 7829.2550, subp. 3 requires the following types of notice:

- direct mail notice, based on county tax assessment rolls, to landowners reasonably likely to be affected by the proposed transmission line;
- direct mail notice to all mailing addresses within the area reasonably likely to be affected by the proposed transmission line;
- direct mail notice to tribal governments and to the governments of towns, statutory cities, home rule charter cities, and counties whose jurisdictions are reasonably likely to be affected by the proposed transmission line; and
- newspaper notice to members of the public in areas reasonably likely to be affected by the proposed transmission line.

Regarding landowner and resident notice, Plum Creek proposed to provide notice to landowners in the notice area¹ via names and addresses obtained using county tax assessment rolls, other relevant county records, and mailing lists maintained by the United States Postal Service or bulk mailing firms. The Department concludes that this is reasonable.

Regarding newspaper notice, the Applicant listed and selected three local newspapers. The Department concludes that the Applicants' proposed plan for newspaper notice is reasonable.

Regarding governmental notice, the Department's review of Plum Creek's list of governments proposed to receive notice complies with the requirements of the rule, with the addition of certain governmental bodies. Regarding tribal governments, the Applicant proposed to notify the Lower Sioux Indian Community. The Department recommends that the Applicant also provide notice to state and federal senators and representatives whose districts are within the Notice Area. With these modifications the Department concludes that Plum Creek's proposed Notice plan for local governments is reasonable.

In summary, the Department concludes that the Applicant's Notice Plan for residents, landowners, and governmental entities is reasonable with the addition of notification of state and federal senators and representatives whose districts are within the Notice Area.

B. CONTENT OF NOTICE

Minnesota Rules 7829.2550, subp. 4 require the notices to provide the following information:

- A. a map showing the end points of the line and existing transmission facilities in the area;
- B. a description of general right-of-way requirements for a line of the size and voltage proposed and a statement that the applicant intends to acquire property rights for the right-of-way that the proposed line will require;
- C. a notice that the line cannot be constructed unless the [Minnesota Public Utilities Commission (Commission)] certifies that it is needed;
- D. the Commission's mailing address, telephone number, and website;
- E. if the applicant is a utility subject to chapter 7848, the address of the website on which the utility applicant will post or has posted its biennial transmission projects report required under that chapter;
- F. a statement that the Environmental Quality Board^[2] will be preparing an environmental report on each high-voltage transmission line for which certification is requested;
- G. a brief explanation of how to get on the mailing list for the Environmental Quality Board's proceeding; and

H. a statement that requests for certification of high-voltage transmission lines are governed by Minnesota law, including specifically chapter 4410, parts 7849.0010 to 7849.0400, and 7849.1000 to 7849.2100, and Minnesota Statutes, section 216B.243.

The Department reviewed the cover letters and maps provided by the Applicant and concludes that the Applicant's proposal for the resident/landowner notice, governmental notice, and newspaper notice generally contains the required information and is acceptable, with one exception. The Department notes that Minnesota Rules 7829.2550, subp. 4(H) requires that the notification letters include a list of Minnesota laws that are applicable, including Chapters 4410 and 7849, and Minnesota Statutes, section 216B.243. Plum Creek's letters do not include references to Chapter 4410, and thus the Department recommends that references to Chapter 4410 be included in the notification letters.

The Department concludes that, with the modification to include reference to Minnesota Rules Chapter 4410 in the notification letters, the Applicant's proposed notice content is reasonable.

III. DEPARTMENT RECOMMENDATIONS

As discussed above, the Department recommends that the Commission approve the Applicant's proposed Notice Plan with the following modifications:

- include notification of state and federal senators and representatives whose districts are within the Notice Area, and
- include reference to Minnesota Rules Chapter 4410 in the notification letters.
