NORTH MANKATO EXCEPTIONS TO ADMINISTRATIVE LAW JUDGE'S REPORT

TO: Honorable Daniel P. Wolf, Executive Secretary, Minnesota Public Utilities Commission, 121 7th Place East, Suite 350, St. Paul, MN 55101

For the purpose of ensuring the clarity and accuracy of the record, the City of North Mankato ("North Mankato") respectfully submits to the Minnesota Public Utilities Commission ("Commission") the following table of exceptions to the Findings of Fact, Conclusions of Law, and Recommendation ("ALJ Report") issued by Administrative Law Judge Barbara Case ("ALJ") for the proposed Huntley to Wilmarth 345 kilovolt (kV) transmission line project. In the table below, North Mankato's recommended additions are underlined, while language it recommends be deleted is stricken.

A	North Mankato requests that the Commission edit certificate of need Finding 26 to reflect that North Mankato's objections to the Red and Green routes were not limited to the routes' conflicts with planned development efforts, but North Mankato also objected on grounds that the routes would impact or conflict with existing homes and development.	26. On February 6, 2018, North Mankato submitted Comments on the Completeness of the Certificate of Need and Route Permit Applications, stating North Mankato's objection to all portions of the Red and Green routes that conflict with existing, short-term, and long-term development as identified in North Mankato's Comprehensive Development Plan. ⁵⁷
В	North Mankato requests that the Commission edit certificate of need Finding 60 to: (a) correct the spelling of the word "filed;" and, (b) include a summary of the objections raised by North Mankato witness Michael Fischer. (Ex. NM-1 at 10:9-13).	60. On November 7, 2018, North Mankato filed the Direct Testimony and Schedules of Michael Fischer, stating that the Red and Green Route Alternatives and Segment Alternatives A and B would place a new, above ground EHV transmission line directly through or in close proximity to planned development, existing and planned infrastructure, and existing homes. 104
С	North Mankato requests that the Commission edit certificate of need Finding 82 to reflect that North Mankato witness Michael Fischer testified that the Red and Green routes conflict with existing residences as well as proposed developments. (<i>See</i> Ex. NM-17 at 6:17-20).	82. On January 28, 2019, North Mankato filed the Surrebuttal Testimony of Michael Fischer, restating that the Red and Green routes, including Segment Alternatives A and B, are incompatible with the City's existing residences and growth plansned developments as outlined in the Comprehensive Development Plan. 129

North Mankato requests that the Commission edit route permit Finding 304 to: (a) delete the word "the" preceding "its near- and longterm growth plans" in the second sentence; (b) reflect North Mankato's testimony that the Red and Green routes would impact not just planned development, but existing residences and infrastructure as well. (See, e.g., Ex. NM-1 at 13:20 – 14:3; Ex.NM-14 (map and table depicting proximity of proposed Red and Green routes to existing and planned homes in the North Mankato area)); and, (c) edit footnote citation 896 associated with route permit Finding 304.

304. North Mankato opposes those portions of the Red and Green Routes that begin where the Routes turn south from the existing transmission line at Belgrade Township and end where the Red and Green Routes meet Segment Alternative E. The City states that these route options would come in close proximity to existing homes and would also interfere with the its near- and longterm growth plans described in the Comprehensive Development Plan adopted in 2015. The Red and Green Routes and Segment Alternatives A and B traverse through the planned North Ridge Residential Development Area and North Mankato South Boundary Residential Area. 896 According to North Mankato, 183 new homes will be added within 500 feet of the proposed Red and Green Routes.897

North Mankato requests that the Commission edit route permit Finding 304 to: (a) delete the word "the" preceding "its adopted land use" in the first sentence; and, (b) correct a reference to North Mankato that appears intended to refer to Mankato.

307. The City of Mankato submitted comments on the Draft EIS, stating that the Blue Route conflicts with the its adopted land use and growth plans, future expansion of the Mankato Regional Airport, and maintenance of the forested wetland areas located between Mankato and the City of Eagle Lake. 906 The City of Mankato noted that the area between the cities of Mankato and Eagle Lake has, and will have in the near future, the fastest growing population in the Project area. 907 This area has already experienced significant public and private infrastructure investment reflecting the urban development. The City of North-Mankato requested that the Draft EIS be amended to state that the Blue Route's impacts on aesthetics, displacement, zoning and land use, public services, and flora are "moderate to significant and likely unable to be mitigated."908
