Enclosed please find Enbridge Energy, Limited Partnership's ("Enbridge") Application for a Pipeline Routing Permit and Partial Exemption (the "Application") for the Fond du Lac Line 4 Project in Minnesota on the Fond du Lac Reservation (the "Project"), which has been e-filed today through www.edockets.state.mn.us.

The Project is being proposed in response to a request from the Fond du Lac Band of Lake Superior Chippewa ("Fond du Lac Band") requesting that Enbridge remediate an above-grade segment of Line 4 installed in the 1970s through the Fond du Lac Reservation in St. Louis and Carlton Counties. Fond du Lac Band has raised concerns that the above-grade Line 4 segment installed through the Fond du Lac Reservation creates a barrier to the natural water flow across the Reservation and, in some areas, impedes land access for the Band members. Enbridge thoroughly investigated Fond du Lac's concerns and potential alternatives and, with Fond du Lac's input and support, agreed to relocate and bury approximately 10 miles of the existing 48inch diameter Line 4 pipeline with approximately 10 miles of 36-inch diameter pipeline in the Right-of-Way adjacent to the Enbridge Mainline Corridor. Once the Project is complete, the existing Line 4 segment will be disconnected, deactivated, and removed. Planned future removal of the existing segment of Line 4 in Fond du Lac will provide enhanced access for Band members and allow future environmental remediation of Fond du Lac lands by removing the above-ground pipe.


