CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Minnesota Gas, ("CenterPoint Energy," or the "Company") respectfully submits this letter to notify stakeholders that it discovered an error in its 2017-18 heating season Demand Entitlement petition filed in Docket No. G-008/M-17-533 on November 1, 2017. In that petition, the Company added 20,000 units on the Viking Pipeline as a five-month winter service, but the contract is a twelve-month service.

CenterPoint Energy's initial Demand Entitlement filing for the 2017-2018 Heating Season was filed July 3, 2017, without the additional Viking entitlement. In a supplemental filing made on November 1, 2017, the Company was able to contract for the additional 20,000 units of Viking capacity. The Company added the units as winter only capacity in the Demand Entitlement filing made on November 1, 2017, but the contract is a twelve-month service. In its *Order* dated March 21, 2018, the Minnesota Public Utilities Commission approved the proposed level of demand entitlement and proposed recovery of associated demand costs effective November 1, 2017.

This oversight impacted the Company's Annual Automatic Adjustment ("AAA") (Docket No. G-999/AA-18-374 and G-008/AA-18-573) reports filed September 4, 2018. Additionally, the Demand Entitlement filing for the 2018-2019 Heating Season (G-008/M-18-462) that was filed

on July 2, 2018, and supplemented on November 1, 2018, included the additional 20,000 units for five months instead of twelve. The 2018-19 Demand Entitlement and the 2017-18 Annual Automatic Adjustment review remain open under review with the Department of Commerce, Division of Energy Resources.

CenterPoint Energy intends to produce a complete set of documentation and file corrections to the relevant dockets to reconcile this issue. The costs of the Viking contract were paid, beginning November 1, 2017, but those costs were only partially recovered (five months versus twelve months) in the corresponding Purchase Gas Adjustments. As a result, the difference has been rolled in to the AAA/true-up under-recovery that was implemented on September 1, 2018, and the Company will include this issue in comments to be filed in that AAA docket. In addition, the Company will incorporate the change into its upcoming Request for Change in Demand Units filing (assigned Docket No. G-008/M-19-278) and its May 2019 PGA (Docket G-008/AA-19-279) to be filed on May 1, 2019.
