Xcel's Alternative Avoided Distribution Capacity Cost method is based on two years of actual and three years of budgeted capacity-related distribution projects.

- a. Please provide all distribution projects for these five years, not just capacity-related projects. Please explain why the other distribution projects are not capacity-related, using the 5 exclusions from capacity-related projects listed on page 10. Provide both the cost (\$) and the added distribution capacity (kW) for these other distribution projects.
- b. Please provide additional available years of capacity-related distribution projects, up to 10 years of actual (historical) and five years of budgeted (forecast). Provide both the cost (\$) and the added distribution capacity (kW) for these other distribution projects.
- c. Please provide all distribution projects for the years provided in part (b) of this question, not just capacity-related projects. Please explain why the other distribution projects are not capacity-related, using the 5 exclusions from capacity-related projects listed on page 10. Provide both the cost (\$) and the added distribution capacity (kW) for these other distribution projects.

Response:

a. See Attachment A to this response. This shows all Electric Distribution project spend for the 5 years. Included on the Notes tab of the spreadsheet is a description of how to sort the data to get the total electric distribution spend and the capacity only spend as historically filed.

Additionally, VOS classifications Blanket, Program, and NA have been included in this Response, although none of these should be included in the VOS calculation. Blankets are small dollar in year reactive nondiscretionary work that is generally reliability based and Program is program-driven spend, which stem from programmatic ongoing work to address an issue or trend over time. NA means

- Not Applicable. This is because the program types are not Capacity and the projects are not capacity related thus the added capacity is zero.
- b. The Company respectfully objects to this request. The Commission has stated that "... it expects parties to respond to information requests in good faith and on a timely basis except if doing so would be unduly burdensome..." (Docket E002/M-13-867, Order of December 21, 2017, page 8). Here, it would be unduly burdensome for the Company to respond to this request as it is seeking 10 years of historical information on capacity-related distribution projects and 5 years of budget forecasts. As noted on page 10 of our May 1, 2019 filing, "Outside of the VOS calculation, the Company does not have a business need to develop a specific category of deferrable capacity-related distribution projects. The identification of deferrable project costs is generally based on the expertise of the distribution personnel with specialized knowledge of the system." It would require a special study to develop information as requested, and given the large time-frame being requested this would be very time consuming and speculative. Notwithstanding this objection, please see response to IR 17-a where information on two years of actual and three years of budgeted capacity-related distribution projects has been addressed.
- c. The Company respectfully objects to this request. The Commission has stated that "... it expects parties to respond to information requests in good faith and on a timely basis except if doing so would be unduly burdensome..." (Docket E002/M-13-867, Order of December 21, 2017, page 8). Here, it would be unduly burdensome for the Company to respond to this request as it seeks 10 years of historical information on all distribution projects and 5 years of budget forecasts. Also, the Company clarifies that the 5 project types were identified as a non- exhaustive list. On page 10 of its May 1, 2019 filing the Company specifically stated that "Outside of the VOS calculation, the Company does not have a business need to develop a specific category of deferrable capacity-related distribution projects. The identification of deferrable project costs is generally based on the expertise of the distribution personnel with specialized knowledge of the system. Projects that are excluded from the deferrable capacity-related project list include those that are driven by: • Asset health, • Equipment failure, • Large customer requirements, • Transmission requirements, and • Reliability requirements." A response to this request would require a special study, and given the large time-frame being requested this would be very time consuming and speculative. Notwithstanding these objections, please see response to IR 17-a where information on two years of actual and three years of budgeted capacity-related distribution projects has been addressed.
