Dear Mr. Wolf:

I represent Detroit Lakes Public Utilities, a municipal utility duly organized and existing under the laws of the State of Minnesota (the "Municipal"), which is authorized, on behalf of itself and Otter Tail Power ("OTP") (collectively, the "Parties"), to make this filing.

Summary of the Joint Request

This filing constitutes the Parties' joint request that the MPUC update the official service territory map to reflect an agreed-upon change in the Parties' electric service territory boundaries. This joint request concerns the permanent transfer of two areas located within the city limits of the City of Detroit Lakes and within the electric service territory assigned to OTP (identified as the "Affected Areas"), as further described below.

Legal Authorities

Under Minnesota Statutes, Section 216B.44(a), a municipal utility expands its assigned electric service territory, upon reaching agreement with the neighboring utility as to compensation: "Notwithstanding the provisions of sections 216B.38 to 216B.42, whenever a municipality which owns and operates an electric utility (1) extends its corporate boundaries through annexation or consolidation, or (2) determines to extend its service territory within its existing corporate boundaries, the municipality shall thereafter

furnish electric service to these areas unless the area is already receiving electric service from an electric utility, in which event, the municipality may purchase the facilities of the electric utility serving the area." Minn. Stat. § 216B.44(a). In addition, "no electric utility shall render or extend electric service at retail within the assigned service area of another electric utility unless the electric utility consents thereto in writing . . . " Minn. Stat. § 216B.40 (2018).

In the present case, the transfer has occurred pursuant to Section 216B.44: the Affected Area lies within the city limits; the Parties have agreed upon appropriate compensation; and the parties have agreed to the Municipal providing service upon a mutually agreed-upon date.

Minnesota Statutes, Section 216B.39, subd. 3 addresses changes to the assigned service territory map after 1975: "the commission may on its own or at the request of an electric utility make changes in the boundaries of the assigned service areas, but only after notice and hearing ... " By its terms, Section 216B.44(a) excludes Section 216B.39. 216B.44(a) ("notwithstanding the provisions Minn. Stat. Ş of sections 216B.38 to 216B.42,"). Nonetheless, the Parties acknowledge the public policy in having an accurate and updated official service territory boundary map. Accordingly, the Parties request that the Commission update its official records as to electric service territory boundaries to reflect the Parties' permanent change in the Affected Areas.

Underlying Information

Attached as <u>Exhibit A</u> is a map that depicts the boundaries of the Affected Areas (in green). The Affected Areas include one area of approximately 9.48 acres and one area of approximately 3.65 acres. There is one existing commercial customer and one residential remodeling project in the Affected Areas.

Attached as Exhibit B is a legal description of the Affected Areas.

For the convenience and utility planning purposes of both utilities, the Parties have agreed to the Municipal providing electric service to the residential remodeling project, which is under construction. The remaining customer will transfer to the Municipal on a date mutually agreed upon by the Parties, anticipated to occur by the third quarter of 2019.

The Parties acknowledge that the Commission wishes to direct separate notice to customers as to the pending proceeding before the Commission. <u>Exhibit C</u> is a proposed notice to all customers in the Affected Areas. Once a docket number is assigned, the Parties will provide this notice to the applicable customers in the Affected Areas, and they will update the Commission via separate filing.



This letter provides an update as to your electric service provider. As you may know, Detroit Lakes Public Utilities has reached an agreement with Otter Tail Power in which Detroit Lakes will permanently provide electric service to certain customers. By agreement of the utilities, Detroit Lakes is either currently providing your construction service, or will provide electric service on a date determined by the utilities. You will receive more information as the transfer approaches, and the utilities will work together to minimize any disruption in electric service.

In the meantime, the utilities are in the process of formally updating the electric service maps on file with the Minnesota Public Utilities Commission (MPUC) to reflect the change in assigned electric service territory. This letter provides information concerning that MPUC proceeding.
