Dear Mr. Wolf:

Northern States Power Company, doing business as Xcel Energy, respectfully submits these Supplemental Reply Comments to the Minnesota Public Utilities Commission in the above-referenced docket to summarize the permit amendment request record todate.

The Company has made three primary filings related to its Request for Amendment to the Blazing Star 2 Wind Energy Project Site Permit:

- (1) Site Permit Amendment Application (June 19, 2019)<sup>1</sup>
- (2) Reply comments (August 20, 2019)<sup>2</sup>
- (3) Responses to Staff Information Requests Nos. 1-6 (September 18, 2019)<sup>3</sup>

In our responses to Staff Information Requests No.1 and No.3, the Company addresses two recommended changes that arose during the initial and reply comment periods: shifting the location of turbine T-101 by 630 feet, and refining the project boundary. The Company indicated in its responses that it would file a supplement to the June 2019 Amendment Application with both of these changes reflected on a map.

The attached map shows the final project layout and boundary the Company is requesting for the Site Permit Amendment. Importantly, no new landowners are affected by the turbine location shift nor the project boundary reduction. The layout and boundary comply with all permit conditions and state standards<sup>4</sup>, and all environmental information has been updated on the record in the three primary filings made by the Company.

The text within Section 3.1 of the existing Site Permit continues to be accurate as written and no change to the text is requested. However, we ask that the official site map – listed as Attachment B in the existing permit – be changed to the map attached to this letter reflecting the V-110/V-120 turbine layout and updated project boundary.


